RESOLUTION NO. 2018-121

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT WITH PROGRESSIVE WASTE SOLUTIONS OF FLORIDA, INC. D/B/A WASTE CONNECTIONS OF FLORIDA FOR BULK TRASH, YARD WASTE, AND CONSTRUCTION AND DEMOLITION DEBRIS DISPOSAL AND RECYCLABLES PROCESSING SERVICES, PIGGYBACKING THE CITY OF DEERFIELD BEACH INVITATION TO BID (ITB) #2017-18/13; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City entered into an Interlocal Agreement with Broward County for Solid Waste Disposal Support Services in January of 2013; and

WHEREAS, the initial term in the agreement between Broward County and Sun Bergeron for the processing of bulk trash, yard waste, and construction and demolition debris ends in July of 2018; and

WHEREAS, Broward County did not extend the agreement with Sun Bergeron; and

WHEREAS, the City is in need of processing and disposal services for bulk trash, yard waste, and construction and demolition debris; and

WHEREAS, the City desires that the aforementioned materials not be disposed of at the Monarch Hill Landfill; and

WHEREAS, the City of Deerfield Beach has awarded a contract to Progressive Waste Solutions of Florida, Inc. D/B/A Waste Connections of Florida to provide recyclables processing for the above-mentioned materials with non-recyclable materials going to their St. Cloud, Florida landfill; and

WHEREAS, Staff recommends entering into an Agreement with Progressive Waste Solutions of Florida, Inc. D/B/A Waste Connections of Florida to provide the aforementioned services; and

WHEREAS, the City Commission believes it to be in the best interest of the City to execute an Agreement with Progressive Waste Solutions of Florida, Inc. D/B/A Waste Connections of Florida for the purpose of providing bulk trash, yard waste, and construction and demolition debris disposal and recyclables processing services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of the Resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the Piggyback Agreement with Progressive Waste Solutions of Florida, Inc. D/B/A Waste Connections of Florida for the purpose of providing bulk trash, yard waste, and construction and demolition debris disposal and recyclables processing services for the aforementioned materials pursuant to the City of Deerfield Beach ITB #2017-18/13.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the Agreement with Progressive Waste Solutions of Florida, Inc. D/B/A Waste Connections of Florida for the aforementioned purpose.

<u>Section 4:</u> That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
