## **RESOLUTION NO. 2022-216**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND TEAM SERVICES FLORIDA, LLC TO PROVIDE SPORTS OFFICIATING SERVICES PURSUANT TO IFB NO. 09-07-22-12; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, sports officials fill the critical role of making sure athletic sports leagues are played fairly and well-managed in a safe environment for all participants and spectators; and

**WHEREAS**, the work consists of furnishing all labor, service, and supervision necessary to properly officiate sports events in a safe, effective, and efficient manner, on an as-needed basis; and

WHEREAS, on August 21, 2022, the City issued Invitation For Bids No. 09-07-22-12 for Sports Officiating Services, and on September 7, 2022, the City opened bid submittals from three (3) companies, including: 1) Team Services Florida, LLC; 2) SuperSports of Broward County; and 3) Teddy Brown Official Business; and

**WHEREAS**, the bid submitted by Teddy Brown Official Business was determined to be non-responsive due to not submitting any required documents; and

WHEREAS, SuperSports of Broward County withdrew their bid submission; and

WHEREAS, after reviewing the remaining bid, Lenore Thomas, Parks and Recreation Superintendent, and Melissa See, Parks and Recreation Supevisor, determined that Team Services Florida, LLC submitted a responsive and responsible bid; and

**WHEREAS**, the initial contract period will begin following approval of this resolution

and full execution of the agreement, attached hereto as Exhibit "1," and will expire three (3) years from that date; however, the City may extend the contract for two (2) additional one (1) year periods, providing each party agrees to the extension under the same terms, conditions, and specifications; and

WHEREAS, the City Commission finds and determines it to be the best interest of the City to enter into an agreement with Team Services Florida, LLC for Sports Officiating Services.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE **CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. The agreement, identified as Exhibit "1," attached hereto is incorporated herein and made a specific part of this resolution.

That the City Commission has reviewed and hereby approves the Section 2: attached agreement between the City of Coconut Creek and Team Services Florida, LLC for Sports Officiating Services pursuant to IFB No. 09-07-22-12.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Team Services Florida, LLC for Sports Officiating Services pursuant to IFB No. 09-07-22-12.

That if any clause, section, other part or application of this resolution Section 4: is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
