1. Call to Order

The regular meeting of the Northwest Council of Elected Officials was called to order on Monday, December 9, 2024, at 12:27 p.m. by Mayor Scott J. Brook of the City of Coral Springs.

2. Introductions

Mayor Scott J. Brook facilitated attendee introductions. Self-introductions were made by attendees and council members.

3. Approval of Minutes

October 14th meeting hosted by the City of Tamarac

ACTION:

- Mayor Rich Walker moved to approve the minutes of October 14, 2024, as presented.
- Commissioner Joshua Simmons seconded the motion.

4. Staff Presentation

Commission Video Messaging (Lynne Martzall, Director of Communications & Marketing)

Deputy City Manager Catherine Givens spoke on her connection to the education system in the City of Coral Springs. Ms. Givens acknowledged the City of Coral Springs' longstanding focus on education, which culminated in the City of Coral Springs' establishment of an education office and the creation of a new position - Education Relations Manager. Selected to serve in this capacity, April Wyche was recognized by Deputy City Manager Givens.

Ms. Martzall presented on the "Effective Communication Strategies for Neighborhood Schools". The presentation was made a part of the record. Topics discussed included:

- Alignment of the city's communication plan with the city's vision and number one strategic goal for which quality schools are an integral part.
- Involvement of the Principal Education Group and the Parent Education Group
- Online Neighborhood Schools Guide with content driven by principals
- City's local magazine - "Under the Sun" - to highlight events and activities being held in the City of Coral Springs as well as parent involvement.
- City banners installed at all schools with the City of Coral Springs' social media platforms including QR (Quick Response) codes directing the public to the city's website and advertising current events and city services.
- Teen Political Forum
- Partnership program with lower scoring schools, allowing employees to offer tutoring, go into classrooms, and help with candy fundraising drives to build relationships and promote what the city is about – public servants that give back.
- Promotion in hyper-local magazines (such as *Sports and Activities* magazine, *Spectator* magazine, etc.) of the Education Relations Manager and what they do.
- Video messages issued to schools before the 1st of every month featuring members of the Coral Springs City Commission. These videos highlight current events and available activities which have been fundamental in creating more opportunities for teen volunteer recruitment. The current video message for the month of December featuring Commissioner Joshua Simmons was played for the room.

Lynne Martzall and April Wyche fielded questions from the Council members.

Commissioner Melissa P. Dunn of the City of Lauderhill inquired about HR or union contract challenges related to making it open to city staff to volunteer at the schools. Deputy City

Manager Catherine Givens was asked to provide a copy of the city's Engaging Employees through Volunteerism policy.

5. Old Business – None.

6. New Business

Mayor Scott Brook asked the Council members in attendance about what their cities do for veterans. Mentioning his personal family ties to a veteran, his father, Mayor Scott Brook voiced his support for the Council members and their respective cities partnering together to recognize veterans. Responses included:

- Commissioner John A. Brodie advised that the City of Coconut Creek does something for veterans every day and that he is a veteran. Further, Coconut Creek is working on a dog-friendly program for veterans.
- Mayor Arlene R. Schwartz advised that the City of Margate has a Veteran's Pantry.
- Commissioner Joanne Simone added that the city also provides yard signs at no cost to veterans; wreaths can be bought to be placed on the headstones of veterans who have passed away; and there was a veterans parking program.

Mayor Scott Brook proposed that The Northwest Council of Elected Officials come together to do some form of recognition for veterans by March 31st, 2025.

- Mayor Arlene R. Schwartz seconded the motion.
