

**RESOLUTION NO. 2014 -**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE MAYOR OF COCONUT CREEK TO EXECUTE AN AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND THE CITY OF MARGATE DATED OCTOBER 1, 2010 PROVIDING FOR DELIVERY OF EMERGENCY MEDICAL AND FIRE PROTECTION SERVICES IN ORDER TO EXTEND THE TERM OF THE AGREEMENT FOR ONE (1) YEAR; IN ORDER TO PROVIDE FOR INCREASED FEES TO MARGATE; AND IN ORDER TO PROVIDE FOR TOTAL REIMBURSEMENT OF EMS BILLING COLLECTIONS REVENUE BY MARGATE TO COCONUT CREEK FOR THOSE SERVICES PROVIDED WITHIN COCONUT CREEK; AND IN ORDER TO PROVIDE FOR CLARIFICATION REGARDING STAFFING AND EQUIPMENT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek and the City of Margate entered into an Interlocal Agreement on October 1, 2010. Said Interlocal Agreement provided for the delivery of emergency medical and fire protection services by Margate to Coconut Creek in order to protect the health, safety, and welfare of the residents of Coconut Creek; and

**WHEREAS**, the October 1, 2010 Interlocal Agreement is due to expire on September 30, 2014 and both parties are desirous of extending the term of the Agreement for one (1) year until September 30, 2015 in order to avoid any lapse in the delivery of emergency medical and fire protection services to the residents of the City of Coconut Creek; and

**WHEREAS**, both parties have agreed that Margate shall provide Special Response Team (SRT) Paramedics to accompany and deploy with the Coconut Creek Police SWAT Team as needed; and

**WHEREAS**, Margate shall provide an on-duty Fire/EMS unit for up to five (5) annual Coconut Creek City-sponsored special events as requested by the City

Manager; and

**WHEREAS**, both parties have agreed that the Agreement should be clarified to provide that all Margate Fire Rescue Personnel assigned to Coconut Creek Fire Rescue stations will be provided annual memberships to the Coconut Creek Community Fitness Centers; and

**WHEREAS**, Coconut Creek shall provide and maintain all furniture and station alerting systems at all Coconut Creek locations; and

**WHEREAS**, Coconut Creek agrees to provide and retain ownership of any new fire suppression or rescue vehicles for new Coconut Creek Fire Station 50; and

**WHEREAS**, both parties agree that at Station 94 there shall be at least a minimum of three (3) firefighter/paramedic or EMT personnel on each ALS rescue transport unit and at least two (2) firefighter/paramedic or EMT personnel on each ALS engine; and

**WHEREAS**, Temporary Station 50 (Rowe Center) shall be equipped with an ALS Rescue Transport Unit with at least a minimum of three (3) firefighters/paramedics or EMTs; and

**WHEREAS**, both parties have agreed that a slight increase in the existing annual fee of \$7,174,395 to bring it up to \$7,379,641 is in order due to increases in costs for providing said services provided that a Union Contract is reached between Margate and IAFF providing for personnel pay increases; and

**WHEREAS**, both parties have agreed that Coconut Creek is entitled to be reimbursed at a rate of one hundred percent (100%) of the amount collected by Margate for all Emergency Medical Services Billing for services provided within Coconut Creek less billing service provider fees.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**SECTION 1:** That the City Commission has reviewed and approves the attached Amendment No. 1 to the Interlocal Agreement between the City of Coconut Creek and the City of Margate for Delivery of Emergency Medical and Fire Protection Services.

**SECTION 2:** That the Mayor of Coconut Creek is hereby authorized to execute the attached Amendment No.1 to the Interlocal Agreement between the City of Coconut Creek and the City of Margate for Delivery of Emergency Medical and Fire Protection Services.

**SECTION 3:** That this Resolution shall take effect immediately upon its passage and adoption.
