A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, ACCEPTING A GRANT IN THE AMOUNT OF ONE HUNDRED THOUSAND **DOLLARS** (\$100,000); **AUTHORIZING** THE MANAGER, OR DESIGNEE, TO **EXECUTE** ATTACHED AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT (FDLE) AND THE CITY OF COCONUT CREEK FOR THE JUSTICE ASSISTANCE RESIDUAL **FUNDS** GRANT (JAG); PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek applied for and was awarded the Justice Assistance Residual Funds Grant by FDLE; and

WHEREAS, the grant provides One Hundred Thousand Dollars (\$100,000), which the Coconut Creek Police Department (CCPD) will use to purchase thirteen P-25 compliant mobile radios so officers can establish and maintain effective communications with CCPD personnel and other public service agencies; and

WHEREAS, these radios will supplement officers' current mobile radios; and

WHEREAS, the CCPD will use this enhanced ability to communicate effectively and coordinate responses to life-threatening situations in the most efficient manner possible.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission hereby accepts the FDLE JAG Residual Funds Grant in the amount of \$100,000.

<u>Section 3:</u> That the City Commission has reviewed and hereby approves the attached agreement between the FDLE and the City for the purpose of purchasing thirteen P-25 compliant mobile radios to upgrade the CCPD's wireless communications capabilities.

Section 4: That the City Manager, or designee, is hereby authorized to execute said agreement between the FDLE and the City, attached hereto and made a part hereof.

Section 5: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 6: That this resolution shall be in full force and effect immediately upon its adoption.
