Completed Dispatch Tasks

Hardware and Software:

- Coconut Creek is coordinating with Broward County and Coral Springs to obtain the needed hardware and software to add the Fire Rescue units to the Broward Regional Dispatch Center for Oct 1, 2021 – Sept 30, 2022, and Corals Springs Dispatch starting Oct 1, 2022. This includes:
 - Fire Records Management System
 - EMS reporting
 - Automatic Vehicle Location for Closest Unit Response

Fiber Optic Line:

 The fiber optic line between Coral Springs and Coconut Creek is complete. This ensures high speed communication between the two cities, including availability and redundancy, and will ensure the dispatch system functions reliably.

Completed Dispatch Tasks

- Police and Fire/EMS Dispatch Center
 - Coconut Creek is providing GIS mapping data and response zone data to Coral Springs. This data will go into the Coral Springs CAD system to ensure a seamless transition in 2022.

Vision




Performance Goal

Department Organization

- The Coconut Creek Fire Rescue Department will include 88 positions:
 - 72 uniformed personnel working the operational shift of 24 hours on-duty and 48 hours off-duty
 - Optimal daily staffing of 19 (minimum of 16)
 - 11 uniformed administrative personnel
 - Four (4) non-uniformed administrative personnel
 - One (1) contracted Medical Director

Additionally, four (4) staff members will be added as support positions (Human Resources, Purchasing, Payroll, and IT).

Automatic Aid and Mutual Aid Agreements

- ISO requires the use of <u>Automatic Aid Agreements</u> throughout the entire city to ensure prompt fire response to our residents and to meet the ISO requirements.
- We have <u>Automatic Aid Agreements</u> in place with Coral Springs and BSO/Deerfield Beach – these are being updated to remain in effect after October 1, 2021.
- We are currently seeking additional <u>Automatic Aid Agreements</u> with Pompano Beach and Margate for the remaining part of the City.
- We are currently reviewing a proposed county-wide <u>Automatic Aid,</u> <u>Closest Unit Response, and Mutual Aid Agreement</u> through the Fire Chiefs Association of Broward County and anticipate signing this agreement at the same time as every other municipality in Broward County.

<u>Budget</u>

Coconut Creek is in the Process of:

- Securing contracts, licenses, and other administrative items needed for operations;
- Adding additional software and updating the payroll system to handle the unique scheduling that comes with the Fire Rescue Department;
- Developing a training program that all new Coconut Creek Fire Rescue employees will complete during September, 2021; and
- Finalizing a Fire Rescue Department Manual, EMS protocols, Administrative Orders, and a Logistics Plan.

We are working to have the following contracts in place prior to September 1, 2021:

- Medical Supply Purchase
- EMS Billing
- Radio Maintenance
- Large Vehicle Maintenance
- Medical Waste Disposal
- Fire Equipment Purchase
- Ladder Testing & Maintenance

- Uniform Purchase
- Fire Station Alerting Repair & Maintenance
- Hose Testing & Maintenance
- SCBA Testing & Maintenance
- Medical Equipment Repair & Maintenance
- Stretcher Repair & Maintenance
- Bunker Gear Cleaning, Repair & Maintenance

Coconut Creek is in the Process of:

- Submitting an <u>ALS application</u> to the State of Florida to allow us to begin ALS/BLS transport by October 1, 2021.
 - Our current Broward County Certificate of Convenience and Need is being retitled with the new name of Coconut Creek Fire Rescue.

- Applying to the State of Florida to re-instate our <u>National Fire Incident</u> <u>Reporting number</u> and <u>Florida Fire Incident Reporting number</u>.
 - This will allow us to begin providing fire service and sending data reports to the State and FEMA beginning on October 1, 2021.
