CALL TO ORDER

Mayor Belvedere called the meeting to order at 7:06 p.m.

Mayor Belvedere asked all to rise for the Pledge of Allegiance led by the Coconut Creek Honor Guard.

Vice Mayor Rydell made a motion to excuse Commissioner Tooley from the meeting, and Commissioner Welch seconded it. All were in favor, and the motion carried.

PRESENTATIONS

Police Chief Albert "Butch" Arenal spoke about the accomplishments of Police Officer Scott Slavin and invited him and his family to come forward for the badge pinning ceremony.

2. 17-010 A PRESENTATION TO HONOR SERGEANT STEPHEN R. GUENTHER AND OFFICER STEVEN J. DANIELLO.

City Manager Blasi gave a history of Police Sergeant Stephen Guenther's experience and his accomplishments and presented him with a Waterford Crystal eagle to thank him for his dedicated service to the City. Police Chief Arenal presented him with his retiree credentials.

City Manager Blasi then gave a history of Police Officer Steven Daniello's experience and his accomplishments and presented him with a Waterford Crystal eagle to thank him for his dedicated service to the City. Police Officer Daniello addressed the Commission, his colleagues, and the audience.

INPUT FROM RESIDENTS OF COCONUT CREEK

Raymond Lebowitz, 3950 D Cocoplum Circle, Coconut Creek, discussed parking issues at *The Promenade* and suggested that employees park in the garages or other lots to make parking spaces more available to the patrons. City Manager Blasi commented that the City had been working with the property owners to address the parking concerns. Sustainable Development Director Sheila Rose reported that the property owners of *The Promenade* negotiated a short-term agreement with the School Board for parking at Monarch High School Thursday through Saturday. She noted that the property owner was researching long-term solutions that could include acquiring vacant land behind the *Silverspot Movie Theater* or expanding the existing parking garages, and explained that City staff continued to offer alternative solutions to address the concerns. Commissioner Sarbone asked that staff follow up on the status of the short-term agreement for valet parking. Discussion ensued.

City Attorney Pyburn had no report.

COMMISSION COMMUNICATIONS

Commissioner Welch thanked the Police Department for traffic enforcement efforts on Lyons Road between Wiles Road and Sample Road. She commented on the Creek Idol singing competition held at the Township Performing Arts Center on January 19, 2017, and commended all of the performers who competed. She attended the Safe Streets Summit and participated in the bike ride study to understand how bike lanes would be implemented under the City's Complete Streets initiative. She reported that Coconut Creek High School increased their school rating, which made them eligible to receive additional funding for teachers and school resource officers to continue improving the school.

Commissioner Sarbone spoke about the lack of landscape buffer by the tomato fields on Lyons Road between Sample Road and Wiles Road, and asked staff to contact the property owner to address code enforcement issues on the west side of the property adjacent to the City's ten-acre parcel. Director of Sustainable Development Sheila Rose responded to Commissioner Sarbone's concerns and reported that staff had spoken with the property owner's attorney to advise them of the accruing code enforcement fines for the property along Lyons Road. She added that staff would be issuing a summons for the code issues along the west side of the property at Wochna Boulevard.

She instructed the speakers, when they come forward to speak, to state their name and address clearly for the record and whether or not they were sworn-in and understand the rules of the proceedings.

George Platt of LSN Partners, representing the Applicant, introduced himself and noted that he was present to answer any questions. The Commission opened discussion with the liquor store hours of operation. Discussion ensued regarding alternative closing times and the existing provisions in the City Code.

Mayor Belvedere opened the public hearing. There were no questions or comments from the public, and the public hearing was closed.

AMENDMENT: Sarbone/Welch – To amend Ordinance No. 2017-001 to add a condition of approval requiring the applicant to provide a report six months after the store's opening detailing sales data and for the Police Chief to submit a report detailing public safety concerns.
