

RESOLUTION NO. 2020-152

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, SUPPORTING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S (FDOT) MANAGEMENT, CONSTRUCTION, AND DELIVERY OF THE COPANS ROAD MOBILITY IMPROVEMENTS PROJECT, FM NO. 429576-5, FROM SR7/441 TO APPROXIMATELY 1,200 FEET WEST OF LYONS ROAD IN ACCORDANCE WITH THE FDOT MOBILITY PROGRAM MANAGEMENT; PROVIDING FOR DISTRIBUTION; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 24, 2013, the City Commission of the City of Coconut Creek approved Resolution No. 2013-112 in support of the Complete Streets Guidelines to allow all users, including people who walk, bike, use transit, and drive, to safely navigate our roadways; and

WHEREAS, the Copans Road Mobility Improvements Project has been defined as an off-system prioritized project within the local right-of-way/jurisdiction of the City of Coconut Creek and the City of Margate that is not located on the State Highway System; and

WHEREAS, the Florida Department of Transportation (FDOT) is authorized to undertake the project identified as FM No. 429576.5 within the City of Coconut Creek's and the City of Margate's municipal limits; and

WHEREAS, a resolution to endorse FDOT's delivery of said project within the local agency's right-of-way/local jurisdiction is required; and

WHEREAS, FDOT provides for a public involvement process, and the City retains final approval of the design to be constructed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

Section 2: That the City Commission hereby supports FDOT's management, construction, and delivery of the Copans Road Mobility Improvements Project. identified by FDOT as FM No. 429576-5, along Copans Road from SR7/441 (Margate, FL) to approximately 1,200 feet west of Lyons Road with an overall project length of 1.069 miles of Copans Road in accordance with FDOT's Program Mobility Improvements.



Section 3: That the City Clerk is hereby directed to provide a copy of this resolution to FDOT.
