A Public Outreach Meeting was held for proposed improvements to the Walmart Store #1916 located at 5571 W. Hillsboro Blvd., Coconut Creek, FL 33073. The meeting was held at the Recreation Complex located at 4455 Sol Press Blvd., Coconut Creek, FL 33073. The meeting took place in the Oak Room on Thursday, April 30, 2026, from 5:00 PM to 7:00 PM.

All residents and businesses within a 700-foot radius of the Walmart location were provided notice of the Public Outreach Meeting two weeks in advance. The purpose of the meeting was to present the scope of the project and address any comments, questions, or concerns. The project was presented using poster boards displaying the most recent site plan and project information.

No community members attended the meeting; therefore, no comments or negative feedback were received during the public outreach process.

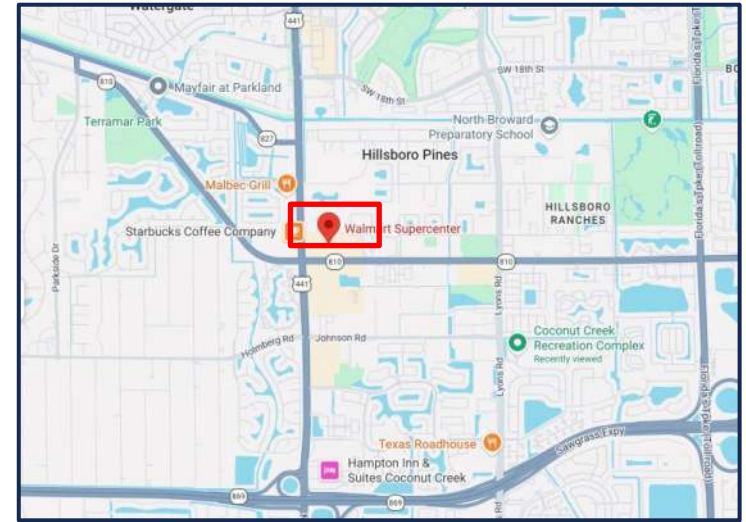

- This expansion will house the operations and storage for the online pickup program.

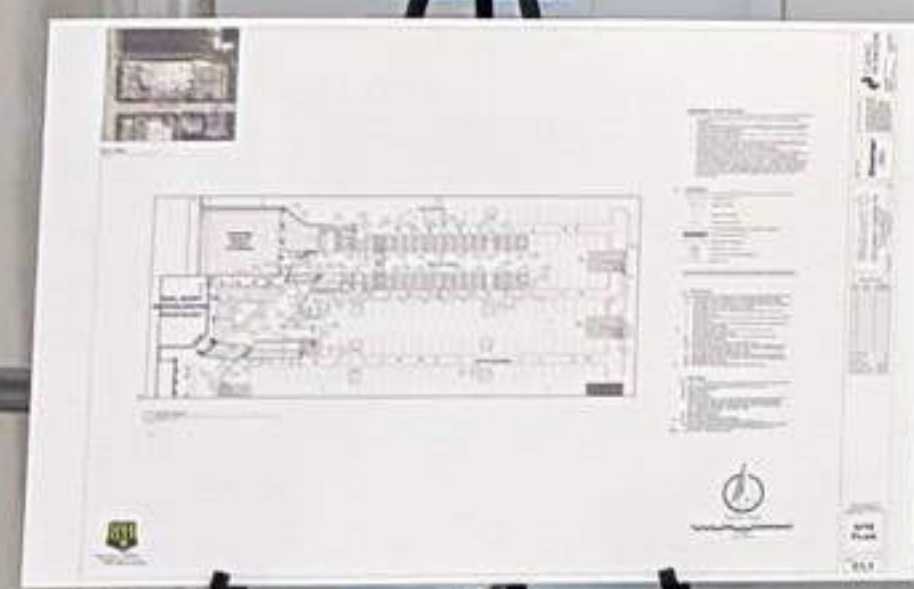
Pickup Parking
