A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AMENDMENT NO. 2 TO THE AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND EDJ SERVICE, INC. FOR LANDSCAPE MAINTENANCE SERVICES DATED SEPTEMBER 12, 2013, FOR MEDIAN AND RIGHT-OF-WAY MAINTENANCE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the City of Coconut Creek entered into an agreement with EDJ Service, Inc. on September 12, 2013, for landscape maintenance services pursuant to RFP No. 07-23-13-10; and

**WHEREAS**, the City of Coconut Creek has made landscaping improvements that require additional maintenance on Coconut Creek Parkway, Copans Road, and Lyons Road; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the residents of Coconut Creek to approve Amendment No. 2 to the Agreement between the City of Coconut Creek and EDJ Service, Inc. for the additional landscape maintenance services.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

**Section 1:** That the City Commission has reviewed and hereby approves the attached Amendment No. 2 between the City of Coconut Creek and EDJ Service, Inc.
