

**RESOLUTION NO. 2023-088**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED VOLUNTARY COOPERATION MUTUAL AID AGREEMENT RENEWAL AMONG THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT (FDLE) AND PARTICIPATING AGENCIES TO FORM A MIAMI REGIONAL OPERATIONS CENTER CHILD ABDUCTION RESPONSE TEAM (CART); PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Section 23.1225 (1), (2), Florida Statutes, known as the “Florida Mutual Aid Act,” the Coconut Creek Police Department (CCPD) and other agencies have the authority to enter into voluntary mutual aid agreements for cooperation and assistance of a routine law enforcement nature across jurisdictional lines; and

**WHEREAS**, the Coconut Creek Police Department and other member agencies are all participants in a multi-agency effort known collectively as the Child Abduction Response Team (CART); and

**WHEREAS**, the Coconut Creek Police Department previously renewed the mutual aid agreement in October 2020 (“Old Agreement”); and

**WHEREAS**, the Old Agreement is currently in place and unexpired; however, this new proposed agreement changes the name from the South Florida Child Abduction Response Team to the Miami Regional Operations Center Child Abduction Response Team and the new proposed agreement is with the newly-appointed FDLE Commissioner and his office.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached agreement by and between the Florida Department of Law Enforcement and the City of Coconut Creek providing for voluntary cooperation between the agencies of CART.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute said agreement between the Florida Department of Law Enforcement and the City of Coconut Creek, attached hereto and made a part hereof.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
