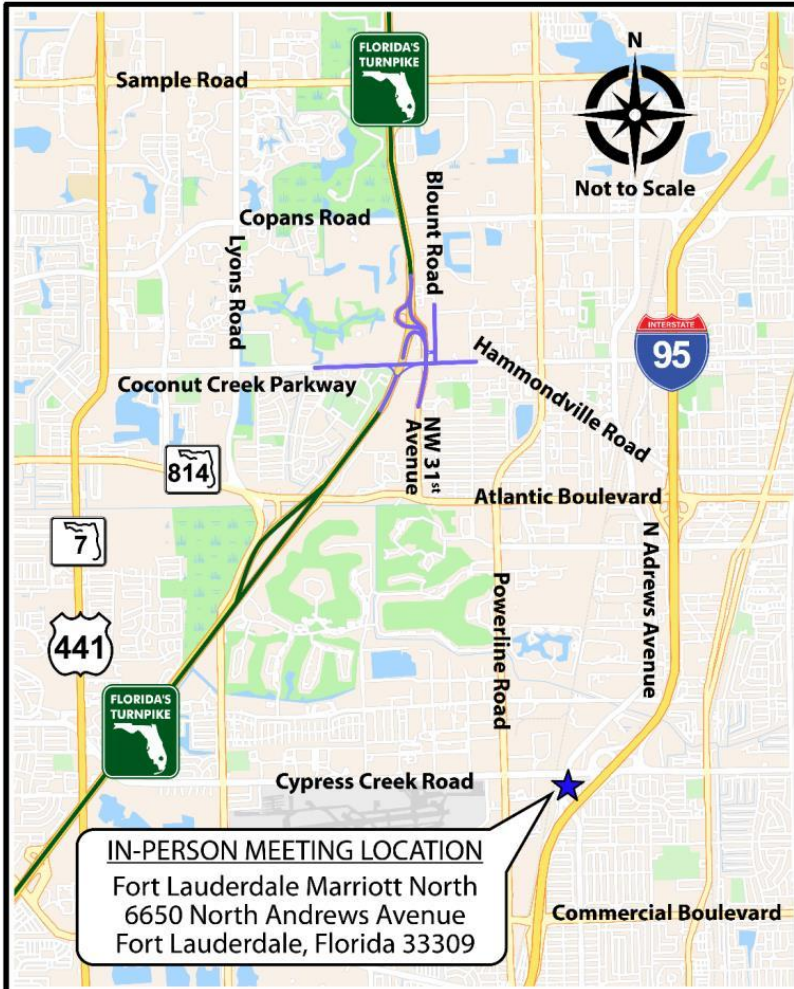

## PROJECT OVERVIEW

The project's objective is to modify the existing interchange at Florida's Turnpike (SR 91) and Coconut Creek Parkway.

## KEY IMPROVEMENTS

- Realigned southbound off-ramp from Florida's Turnpike to Coconut Creek Parkway with a proposed bridge.
- New southbound on-ramp from Coconut Creek Parkway to Florida's Turnpike.
- New northbound off-ramp from Florida's Turnpike to Coconut Creek Parkway.
- Direct connection from Florida's Turnpike southbound off-ramp to Blount Road with a proposed bridge.
- Direct connection from Blount Road to Florida's Turnpike northbound on-ramp.
- New roundabout on Blount Road to connect to Florida's Turnpike.
- Safety improvements related to signs, pavement markings, signals, lighting, and drainage.
- Shared Use Path on Coconut Creek Parkway from NW 39<sup>th</sup> Ave to NW 27<sup>th</sup> Ave.
- Noise walls.
