

**RESOLUTION NO. 2018-019**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A JOINT PARTICIPATION AGREEMENT (JPA) BETWEEN THE CITY AND THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) THAT WILL PROVIDE FOR THE FDOT'S FUNDING TO THE CITY OF \$250,000 FOR THE PURCHASE AND INSTALLATION OF SOLAR POWERED LED BIKE LANE DELINEATORS AT WINSTON PARK BOULEVARD BETWEEN LYONS ROAD AND STATE ROAD 7 (SR-7/US-441); PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the State of Florida Department of Transportation (FDOT) desires to test for a period of twenty-four (24) months a newly developed roadway LED solar powered bike lane delineator specified in the attached Exhibit "A" to be installed flush with the roadway surface at a separation of six (6) feet; and

**WHEREAS**, the City of Coconut Creek is presently engaged in the construction phase of the Comprehensive Street Improvements – Phase I (CSI1) project, which proposes to introduce approximately a one (1) mile bike lane section eastbound and westbound Winston Park Blvd, between Lyons Road and SR-7/US-441, and is a good candidate for said delineators; and

**WHEREAS**, FDOT has presented a JPA for the purpose of compensating the City a not-to-exceed amount of \$250,000, for the procurement and installation of the LED solar powered bike lane delineators on Winston Park Blvd eastbound and westbound, as specified by the JPA; and

**WHEREAS**, the City is able to install said delineators as part of the CSI1 construction agreement with Stanford Construction Co., with a change order to the contract in an amount that will not exceed the JPA allowance of \$250,000; and

**WHEREAS**, the JPA specified LED solar powered delineators present an aesthetic and safety improvement to Winston Park Boulevard and to the bicycle riders,

and City staff is recommending that the City Commission approve execution of the attached JPA by the City Manager or designee.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.


**Section 2:** That the City Commission has reviewed and hereby approves the attached Joint Participation Agreement between the State of Florida Department of Transportation and the City of Coconut Creek to provide for the funding by FDOT of \$250,000 to City in compensation for the procurement and installation of LED solar powered bike lane delineators as specified in the attached Exhibit "A" – Public Transportation Joint Participation Agreement.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached JPA between FDOT and the City of Coconut Creek.


