

**ORDINANCE NO. 2025-049**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING THE CITY'S CODE OF ORDINANCES BY AMENDING CHAPTER 2, "ADMINISTRATION," ARTICLE III, "DEPARTMENTS," DIVISION 2, "POLICE DEPARTMENT," SECTION 2-57, "USE OF OFF-DUTY POLICE OFFICERS OR POLICE SERVICE AIDES FOR UNOFFICIAL FUNCTIONS," TO UPDATE FEES FOR THE USE OF OFF-DUTY POLICE OFFICERS AND POLICE SERVICE AIDES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Chapter 2, "Administration," Article III, "Departments," Division 2, "Police Department," Section 2-57, "Use of off-duty police officers or police service aides for unofficial functions," of the City's Code of Ordinances provides procedures and fees for the hiring of off-duty police officers and supervisors for non-City functions; and

**WHEREAS**, the City desires to update fees in Section 2-57, "Use of off-duty police officers or police service aides for unofficial functions" to align with the updated compensation levels established in the Collective Bargaining Agreements for Fiscal Years 2026 through 2028; and

**WHEREAS**, the City Commission finds and determines that this ordinance is in the best interests of the residents and organizations in the City of Coconut Creek.

**NOW, THEREFORE, THE CITY COMMISSION OF THE CITY OF COCONUT CREEK HEREBY ORDAINS:**

**Section 1: Ratification.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this ordinance.

**Section 2: Amendment.** That the Code of Ordinance of City of Coconut Creek, Florida, shall be amended by amending Chapter 2, "Administration," Article III,

“Departments,” Division 2, “Police Department,” by amending Section 2-57, “Use of off-duty police officers or police service aides for unofficial functions,” to read as follows:

**Chapter 2 – ADMINISTRATION**

**DIVISION 2. – POLICE DEPARTMENT**

Section 2-57. - Use of off-duty police officers or police service aides for unofficial functions.

(e) *Fees:*

(1) a. Any organization or resident receiving services under this division shall be charged a fee of ~~sixty~~ seventy dollars (~~\$60~~70.00) per hour for either a police officer or police service aide. When there is a request for four (4) or more police officers and/or police service aides, one of the officers will be billed at a supervisor rate of ~~seventy~~ eighty dollars (~~\$70~~80.00) per hour, except on holidays as detailed in subsection 2-57(e)(1)b. below.

b. The fee for services under this division on the following city-observed holidays shall be ~~seventy-five~~ eighty-five dollars (~~\$75~~85.00) per hour for police officers and police service aides and ~~ninety~~ one hundred dollars (~~\$90~~100.00) per hour for supervisors:

Martin Luther King Junior's Birthday

Presidents' Day

Memorial Day

Juneteenth

Independence Day

Labor Day

Veterans' Day

Thanksgiving Day

Day after Thanksgiving Day

Christmas Eve

Christmas Day

New Year's Eve

**Section 3: Conflicts.** That all ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this ordinance are hereby repealed to the extent of such conflict.

**Section 4: Severability.** That should any section or provision of this ordinance or any portion thereof, any paragraph, sentence, clause or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder hereof as a whole or part hereof other than the part declared invalid.

**Section 5: Codification.** That the provisions of this ordinance shall be codified within the Code of Ordinances of the City of Coconut Creek, Florida, and any paragraph or section may be renumbered to conform with the Code of Ordinances.

**Section 6: Effective Date.** That this ordinance shall become effective upon its passage on second and final reading.
