Mayor Tooley implemented the Time-Certain at 7:45 p.m. The Input from Residents of Coconut Creek, City Manager Report, City Attorney Report, and Commission Communications were heard after the Consent and Regular Agenda.

#### INPUT FROM RESIDENTS OF COCONUT CREEK

Beth Gastineau, 2170 NW 40 Terrace, Coconut Creek, thanked Police Sergeant Slavin and Police Sergeant Karp for their help addressing traffic issues in the Township Estates neighborhood. She requested that permanent solar speed signs be installed to continue improving the traffic issues.

#### **CITY MANAGER REPORT**

City Manager Blasi announced that the Budget Town Hall Meeting to obtain resident input on the Fiscal Year 2018 budget would be held at 6 p.m. on June 13, 2017. She reported that the City of Coconut Creek was a finalist in the Greater Fort Lauderdale Alliance Economic Development Partner of the Year Award and distributed a handout highlighting the recognition. She recognized GIS Coordinator Ken Brown for his assistance developing a map of all the residential communities in the City and distributed the map to the Commission.

#### CITY ATTORNEY REPORT

City Attorney Pyburn had no report.

#### **COMMISSION COMMUNICATIONS**

Commissioner Belvedere attended a conference regarding the opioid epidemic and was pleased that the Police Department was informed on the issues.

Commissioner Welch noted that the Broward County School Board approved the use of a new educational video on the dangers of opioid use for middle and high school students, but the principals of each school would decide if it is used in each of their respective schools. She attended the Greater Fort Lauderdale Realtors' Mayors Breakfast and Municipal Expo. She recognized Sustainable Development Deputy Director Scott Stoudenmire for representing the City at the Municipal Expo and shared many of the City's recent accomplishments during the panel discussions at the event. She asked staff to provide an update on the Cullum and Lyons Road traffic signal study to share with the Coquina community. She commended the Police Department for their public service announcement at the *Silverspot Cinema*.

Commissioner Sarbone spoke about the Memorial Day Ceremony at Veteran's Park on May 29. He commended the Commission for working well together to serve the needs of the community and was pleased to serve with each of them.

Vice Mayor Rydell echoed Commissioner Sarbone's sentiments and thanked the Commission for their efforts. He attended the *National Kids to Parks Day* hosted by the Parks and Recreation Department at Lakeside Park and was surprised that more residents did not attend the event. He announced that the Broward County Commission ratified his application to serve on the County's Substance Abuse Advisory Board.
