



**Written Approval of Extension of Sale Delay Period Under

This document provides written approval by the County Administrator for Broward County (the "County") and the Mayors of Coconut Creek, Fort Lauderdale, Hollywood, Miramar, Sunrise, and Weston (collectively the "Mayors") to extend the Sale Delay Period under the Second Amendment to Settlement Agreement approved by the County on September 13, 2018 (the "Second Amendment"). The County Administrator and the Mayors agree as follows:

1. Under the Second Amendment, the County and the Settling Municipalities (listed therein) agreed that the sale of Alpha 250 would be delayed for a period of one year from the Effective Date of the Second Amendment (the "Sale Delay Period").
2. The Second Amendment further provides that the Sale Delay Period may be further extended for up to three (3) additional periods, each up to one (1) year, upon written approval of the County Administrator and the Mayors.
