## **RESOLUTION NO. 2017-170**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPOINTING A PLANNING & ZONING BOARD MEMBER TO THE AFFORDABLE HOUSING ADVISORY COMMITTEE PURSUANT TO SECTION 2-255 OF THE CITY OF COCONUT CREEK'S CODE OF ORDINANCES, AND IN ACCORDANCE WITH SECTION 420.9076, FLORIDA STATUTES. **KNOWN** AS THE STATE PARTNERSHIP ACT: PROVIDING FOR INITIATIVES SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on July 28, 2016, the City Commission appointed eight (8) members to the Affordable Housing Advisory Committee (AHAC) with varying qualifications in accordance with Section 2-255 of the City's Code of Ordinances and the requirements of Section 420.9076, Florida Statutes, also known as the State Housing Initiatives Partnership Act; and

**WHEREAS,** on September 22, 2016, the City Commission affirmed the Planning & Zoning Board's recommendation to appoint Alfred Delgado from its membership to serve on the AHAC; and

WHEREAS, following the annual board appointments in April of 2017, the Planning and Zoning Board seat on the AHAC is vacant and there is a need to fill the vacancy; and

**WHEREAS,** on July 12, 2017, the Planning and Zoning Board nominated Doug Young from its membership to fill the Planning and Zoning Board seat on the AHAC.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the City Commission hereby appoints the following individual as a member of the Affordable Housing Advisory Committee to fill the specific role as delineated below, pursuant to Section 2-255, of the City's Code of Ordinances, for the remainder of the three (3) year term, ending on July 28, 2019:
