RESOLUTION NO. 2014 -

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT BETWEEN THE CITY AND SYNALOVSKI ROMANIK SAYE, LLC TO PROVIDE DESIGN AND CONSTRUCTION ADMINISTRATION SERVICES FOR THE RENOVATION AND EXPANSION OF WINDMILL PARK PURSUANT TO RFQ NO. 07-16-14-11 IN THE AMOUNT OF \$246,000.00; PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Commission had expressed a desire to renovate and expand Windmill Park utilizing adjacent land recently purchased from the Johns Family; and

WHEREAS, the City issued a Request for Qualifications (RFQ No. 07-16-14-11) for the purpose of obtaining a qualified firm to design the aforementioned renovations and expansion at Windmill Park; and

WHEREAS, five (5) firms submitted their qualifications for consideration; and

WHEREAS, a Committee consisting of Jim Berkman, Public Works Director, Linda Wiederspan, Parks and Recreation Director, and Brian Rosen, Project Manager reviewed and evaluated the five (5) submittals and entertained presentations from the top three (3) shortlisted firms; and

WHEREAS, based on the criteria of the RFQ including but not limited to staff qualifications, prior experience, ability to perform, and references, the Committee determined that Synalovski Romanik Saye, LLC (SRS) was the most responsive and best suited firm to provide the design services; and

WHEREAS, the aforementioned Committee negotiated the scope of services and fees with Synalovski Romanik Saye, LLC; and

WHEREAS, Staff recommends awarding a contract to Synalovski Romanik Saye, LLC in the amount of \$246,000.00 for the purpose of providing design and construction administration services for the renovation and expansion of Windmill Park; and

WHEREAS, the Coconut Creek City Commission believes that the award of a contract to Synalovski Romanik Saye, LLC in the amount of \$246,000.00 to provide design and construction administration services for the renovation and expansion of Windmill Park is in the best interests of the residents of Coconut Creek.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1</u>: That the City Commission has reviewed and approves the attached agreement between the City of Coconut Creek and Synalovski Romanik Saye, LLC pursuant to RFQ No. 07-16-14-11.

<u>Section 2</u>: That the City Manager or designee is hereby authorized to execute the attached agreement between the City of Coconut Creek and Synalovski Romanik Saye, LLC for the purpose of providing design and construction administration services for the renovation and expansion of Windmill Park in the amount of \$246,000.00.

Section 3: That this Resolution shall take effect immediately upon its passage.
