

**RESOLUTION NO. 2021-085**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE USE OF STATE LAW ENFORCEMENT TRUST FUNDS IN THE AMOUNT OF FIVE THOUSAND DOLLARS (\$5,000) TO PROVIDE A DONATION TO THE FLORIDA POLICE CHIEFS ASSOCIATION (FPCA) EDUCATION AND RESEARCH FOUNDATION PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek has established a State Law Enforcement Trust Fund for the receipt and disbursement of forfeiture monies, pursuant to Section 932.7055, Florida Statutes; and

**WHEREAS**, the FPCA Education And Research Foundation is a 501(c)(3) charitable organization and the Chief of Police has requested that the City Commission make an appropriation from said funds; and

**WHEREAS**, this donation will be used to aid in costs for the FPCA 2021 Summer Training Conference, which will be held in Broward County this year, and training sessions covering issues facing law enforcement will be discussed; and

**WHEREAS**, this appropriation of funds complies with the requirements of the State of Florida Forfeiture Guidelines.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

**Section 2:** That the City Commission hereby approves the appropriation of Five Thousand Dollars (\$5,000) from the Local Law Enforcement Trust Fund for a donation to the FPCA Education and Research Foundation.

**Section 3:** That the City Commission hereby authorizes the City Manager, or designee, to proceed with the above expenditure from forfeiture funds.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
