**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, REPEALING ORDINANCE NO. 2017-040 AND RESCINDING THE PRIOR INVESTMENT POLICY FOR THE CITY THAT WAS ATTACHED THERETO; ADOPTING A NEW INVESTMENT POLICY IN ITS PLACE, ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "A;" AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MANAGE AND OPERATE THE CITY'S INVESTMENT PROGRAM IN ACCORDANCE WITH THE REQUIREMENTS CONTAINED IN EXHIBIT "A;" PROVIDING FOR INVESTMENT OF CITY FUNDS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**
