

**RESOLUTION NO. 2023-053**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPOINTING FIVE (5) REGULAR MEMBERS AND ONE (1) ALTERNATE MEMBER TO THE PLANNING AND ZONING BOARD, PURSUANT TO SECTIONS 2-191, "AUTHORITY OF CITY COMMISSION TO APPOINT BOARD MEMBERS; TERM OF OFFICE OF BOARD MEMBERS," AND 13-16, "PLANNING AND ZONING BOARD," OF THE CITY'S CODE OF ORDINANCES FOR A TERM ENDING WITH THE NEXT APPOINTMENT IN 2024; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, in accordance with Section 2-191(b) of the City's Code of Ordinances, the City Commission shall appoint board members at the second regularly-scheduled Commission meeting each April; and

**WHEREAS**, in accordance with Section 13-16(c) of the City's Code of Ordinances, each member of the City Commission shall nominate one (1) person to fill each position on the Planning and Zoning Board, and one (1) alternate member of the Board shall be selected by the Mayor. A majority of the Commission shall approve the nominations.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the City Commission hereby nominates the following five (5) individuals as regular members of the Planning and Zoning Board, pursuant to Section 13-16(c), Code of Ordinances, for a term ending with the next appointment in 2024:
