

**RESOLUTION NO. 2018-058**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND SOUTH FLORIDA UTILITIES, INC. TO PROVIDE MAINTENANCE ACCESS STRUCTURE AND WET WELL REHABILITATION SERVICES PURSUANT TO BID NO. 01-17-18-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek (City) owns and operates 57 lift stations in its conveyance system; and

**WHEREAS**, all lift stations include a wet well where sewage is collected; and

**WHEREAS**, the conveyance system also uses more than 3,000 maintenance access structures to divert and manage sewage flow; and

**WHEREAS**, both wet wells and maintenance access structures operate in a very corrosive environment where constant rehabilitation is necessary; and

**WHEREAS**, the City issued Bid No. 01-17-18-11 for said rehabilitation services and received responsive bids from two contractors: South Florida Utilities, Inc. and Hinterland Group, Inc.; and

**WHEREAS**, the Purchasing Division reviewed the bid responses for compliance and no issues were found; and

**WHEREAS**, the lowest responsive bidder was found to be South Florida Utilities, Inc.; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with South Florida Utilities, Inc. to provide maintenance access structure and wet well rehabilitation services pursuant to Bid No. 01-

17-18-11.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the Agreement between the City of Coconut Creek and South Florida Utilities, Inc. to provide maintenance access structure and wet well rehabilitation services pursuant to Bid No. 01-17-18-11.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the Agreement between the City of Coconut Creek and South Florida Utilities, Inc.

**Section 4:** That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

**Section 5:** That this Resolution shall be in full force and effect immediately upon its adoption.
