RESOLUTION NO. 2018-002

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE USE OF FEDERAL LAW ENFORCEMENT TRUST FUNDS IN THE AMOUNT OF \$385,540 FOR THE PURCHASE OF POLICE RATED VEHICLES WITH NECESSARY EQUIPMENT, LAPTOPS WITH POLICE SOFTWARE AND ACCESSORIES, MOTOROLA PORTABLE RADIOS WITH ACCESSORIES, SALARY CONTRIBUTION FOR SCHOOL RESOURCE OFFICERS IN FISCAL YEAR 2018, AND BIDIRECTIONAL AMPLIFIER CONDUIT INSTALLATION FOR COCONUT CREEK HIGH SCHOOL; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek has established a Federal Law Enforcement Trust Fund for receipt and disbursement of forfeiture monies, pursuant to the Federal Department of Justice Agreement; and

WHEREAS, the Chief of Police has requested that the City Commission make an appropriation from said funds; and

WHEREAS, on August 11, 2016, the City Commission approved the purchase of a new Bi-direction Amplifier (BDA) system from Motorola Solutions, Inc. ("Motorola") in the amount of \$126,028.00 to be installed at Coconut Creek High School. The amount included the costs of a survey, engineering design, permit fees, project management, and three (3) years of maintenance and annual testing. An additional \$8,000.00 is needed to pay for the conduit installation, which was not included in the original quote but is required by the School Board of Broward County; and

WHEREAS, the funds for the above request will be utilized for law enforcement purposes, including the purchase of capital outlay equipment for police rated vehicles and necessary equipment, laptops with police software and accessories, Motorola portable radios with accessories, salary contribution for School Resource Officers, and bidirectional amplifier conduit installation at Coconut Creek High School, and said request complies with the requirements of the Department of Justice / Treasury Forfeiture Guidelines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission hereby approves the appropriation of \$385,540.00 from the Federal Law Enforcement Trust Fund for police rated vehicles and necessary equipment, laptops with police software and accessories, Motorola portable radios with accessories, salary contribution for School Resource Officers, and bidirectional amplifier conduit installation at Coconut Creek High School.

Section 3: That the City Manager, or designee, is hereby authorized to proceed with the above expenditures from forfeiture funds.

<u>Section 4:</u> That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
