RESOLUTION NO. 2025-139

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY AND ALL-CITY MANAGEMENT SERVICES, INC. FOR SCHOOL CROSSING GUARD SERVICES PURSUANT TO RFP NO. 07-16-25-09; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on June 29, 2025, the City of Coconut Creek issued Request for Proposals (RFP) No. 07-16-25-09 to contract with a qualified company to provide school crossing guard services at various locations in the City of Coconut Creek; and

WHEREAS, the City issued twenty (20) electronic invitations through the eBid System and received three (3) responsive submittals; and

WHEREAS, a selection committee comprised of Francis McManus, Police Sergeant; Robert Lopez, Police Officer; and Natacha Josiah, Planner, evaluated the submittals based on the criteria listed in the RFP; and

WHEREAS, the selection committee ranked All-City Management Services, Inc. as number one (1) based on several factors, including a geo-fenced mobile "Crossing Guard App" to provide real-time alerts to supervisors and annual fit-for-duty assessments; and

WHEREAS, the initial term of the agreement shall be for two (2) years with the option to renew the agreement for three (3) additional one (1) year periods subject to the approval of both parties in writing; and

WHEREAS, based on the results of the reference surveys, proposed pricing, the vendor's proposal, and the evaluations performed, the selection committee is recommending that the City Commission approve award of the contract to All-City Management Services, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has determined that hiring a school crossing guard service is in the best interest of the residents and children of Coconut Creek.

<u>Section 3:</u> That the City Commission has reviewed and hereby approves the attached agreement for school crossing guard services with All-City Management Services, Inc.

<u>Section 4:</u> That the City Manager, or designee, is hereby authorized to execute the attached agreement for school crossing guard services with All-City Management Services, Inc.

<u>Section 5:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 6: That this resolution shall be in full force and effect immediately upon its adoption.
