CALL TO ORDER

Mayor Rydell called the meeting to order at 7:00 p.m. and thanked City Clerk May for the evening's music selection, The Beatles' "Love Is All You Need." Mayor Rydell asked all to rise for the Pledge of Allegiance.

PRESENTATIONS

1. 19-031 A PRESENTATION TO HONOR COCONUT CREEK EMPLOYEE JOANNE LINDHOLM.

City Manager Blasi recognized Ms. Lindholm for her 28 years of dedicated service to the City and presented her with a crystal clock.

INPUT FROM RESIDENTS OF COCONUT CREEK

Susan Steinhauser, 5842 Eagle Cay Circle, Coconut Creek, congratulated the City for achieving the Tree City USA designation for 30 years. She asked for the Commission's support on several environmental topics including a new solar co-op, offshore drilling and seismic blasting, the clean energy lobby day in Tallahassee on March 13, and recycling. Mayor Rydell noted that the City passed a resolution in 2018 that opposed offshore drilling and seismic blasting, and City Manager Blasi explained recent changes to the types of recyclable materials.

City Attorney Pyburn had no report.

COMMISSION COMMUNICATIONS

Commissioner Sarbone wished everyone a happy Valentine's Day. He briefly mentioned the tragedy at Marjory Stoneman Douglas High School one year ago and encouraged everyone to spend time with their families in remembrance.

Commissioner Tooley attended the breakfast held for the first responders who responded to the Marjory Stoneman Douglas High School tragedy.

Commissioner Belvedere attended the Metropolitan Planning Organization (MPO) meeting where they discussed autonomous vehicles. She noted that the federal government recently approved funding for transportation and infrastructure improvements and encouraged staff to review the availability of funds for the City.

Vice Mayor Welch spoke about the Women's Club of Coconut Creek fashion show fundraiser held in January and thanked City staff and leadership for their support of the event. She recognized Public Works Operations Manager Mike Heimbach for speaking to the Women's Club about recycling. She commented on the importance of informing residents that the City's garbage is burned at the waste-to-energy facility and not added to the Monarch Hill landfill. She spoke about the tree planting ceremony held at City Hall earlier in the day to honor the lives lost in the Marjory Stoneman Douglas High School tragedy and recognized Public Works Parks and Natural Resources Lead Worker Terry Adjodha for his efforts in selecting the tree of life for the ceremony.

Mayor Rydell thanked the Commissioners for their representation at the tree planting ceremony at City Hall and in the local schools today and noted that he attended and represented the City at a memorial at the courthouse honoring the lives lost at Marjory Stoneman Douglas High School. He mentioned the passing of Coconut Creek resident and business owner, Jairo Velandia.

Assistant City Manager / Sustainable Development Director Sheila Rose presented the item.

Mayor Rydell opened the public hearing. There were no questions or comments from the public, and the public hearing was closed.

City Attorney Pyburn read aloud the City's quasi-judicial procedures that would be applied to Agenda Items 6 and 7. City Clerk May confirmed that the public notice requirements were met for Agenda Items 6 and 7 and swore in the witnesses. Mayor Rydell asked if there were any objections by the Commission, staff, or the applicant to hear Agenda Items 6 and 7 together as they were all related, and there were none.

City Attorney Pyburn read the title for Ordinance No. 2018-031 into the record.

Commissioner Sarbone made a motion to hear Agenda Item 6, seconded by Commissioner Tooley.

Commissioner Sarbone made a motion to take Agenda Item 7 from the table, seconded by Vice Mayor Welch, and Mayor Rydell read the title for Resolution No. 2018-233 into the record.

Commissioner Tooley made a motion to hear Agenda Item 7, seconded by Vice Mayor Welch.

City Attorney Pyburn asked if there were any disclosures or ex parte communications for Agenda Items 6 and 7 that had not been disclosed since the last meeting, and there were none.

Patricia Ramudo, IBI Group, on behalf of the property owner, Lyons 7600, LLC, shared a PowerPoint presentation and discussed the community outreach efforts conducted by the applicant to the surrounding property owners. She noted that a meeting was held with representatives of the Tall Trees Homeowners Association on February 13, 2019, and commented that easement and shared access agreements with North Broward Preparatory School (NBPS) were provided to the City. She reviewed the site plan details and discussed weekend sports activities held at NBPS. Alex De Angelis, RLC Architects, discussed the building architecture. Discussion ensued with regard to adjacent school activities, parking, and outreach to the Tall Trees community.

Mayor Rydell opened the public hearing. There were no questions or comments from the public. and the public hearing was closed.
