## **RESOLUTION NO. 2024-002**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY AND BIG FUN, INC. TO PROVIDE AMUSEMENT RIDES AND CONCESSION SERVICES PURSUANT TO RFP NO. 11-15-23-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City issued Request for Proposals (RFP) No. 11-15-23-11 to contract with a qualified vendor to provide the City of Coconut Creek amusement rides and concession services for the annual Butterfly Festival event; and

WHEREAS, on October 22, 2023, the City issued ninety-six (96) invitations through the eBid System and received one (1) responsive submittal, which was evaluated by a selection committee consisting of Lenore Thomas, Parks and Recreation Superintendent; Leonardo Moleiro, Special Events Planner; and Amber Venzal, Administrative Assistant to the City Manager; and

**WHEREAS**, the proposal was based on criteria stated in the RFP document, scope of services proposed, reference checks and performance reference surveys; and

**WHEREAS,** the selection committee selected Big Fun, Inc. and is recommending they be awarded the contract for amusement rides and concession services for the Butterfly Festival pursuant to RFP No. 11-15-23-11; and

**WHEREAS**, the initial contract term shall be for three (3) years with the right to extend the contract for one (1) additional fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Big Fun, Inc. to provide amusement rides and concession services for the Butterfly Festival pursuant to the RFP No. 11-15-23-11.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Big Fun, Inc. to provide amusement rides and concession services for the Butterfly Festival pursuant to the RFP No. 11-15-23-11.

<u>Section 4:</u> That if any clause, section, other part or application for this resolution is held by any courts of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
