WITNESSETH

WHEREAS, the Contractor wishes to enter this Agreement ("Agreement") with the City to provide Commingled Waste and Construction and Demolition Debris disposal services to the City; and

WHEREAS, the parties wish to incorporate the terms and conditions of the solicitation ITB No. 2017-18/13 as amended and contractual arrangement between the City of Deerfield Beach, Florida and the Contractor as set forth in the City of Deerfield Beach agreement attached hereto and incorporated herein as Exhibit "A" ("Deerfield Agreement"); and

WHEREAS, the City Code provides authority for the City to select and contract through the use of the competitive bid process of another government entity as an exception to the otherwise required formal bidding process.

NOW THEREFORE, in consideration of the mutual covenants set forth in this Agreement, the receipt and sufficiency of which is acknowledged, the parties agree as follows:

Section 1. Contract Terms. The Contractor agrees to provide the City Commingled Waste and Construction and Demolition Debris disposal services as set forth in the Deerfield Agreement (Exhibit "A"), which terms are incorporated into this Agreement for all purposes and represent the entire agreement between the parties. In the event of conflict between or among this Agreement and the terms and conditions of the Deerfield Agreement, the order of priority shall be: this Agreement, and the Deerfield Agreement.

The following additional provisions are included:

A. The "City of Coconut Creek" shall be deemed substituted for "City of Deerfield Beach, Florida" with regard to any and all provisions of the City of Deerfield Agreement, including by example, and not limitation, with regard to bond requirements, additional insureds on all required insurance, indemnification, licensing, termination, default and ownership of documents. All recitals, representations, and warranties of Contractor made in the Deerfield Agreement (including Contractor's proposal) are restated as if set forth fully herein, made for the benefit of the City, and incorporated herein.
