RESOLUTION NO. 2020-119

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND IMPERIAL ELECTRICAL, INC. FOR SABAL PINES PARK SPORTS LIGHTING REPLACEMENT PURSUANT TO BID NO. 04-15-20-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 15, 2020, the City issued Bid No. 04-15-20-11 to contract with a qualified General and/or Electrical Contractor to furnish and install replacement sports lighting for ballfields #1 and #3 at Sabal Pines Park; and

WHEREAS, the project consists of removing the existing metal halide sport lighting system and replacing it with a new L.E.D. lighting system; and

WHEREAS, the City was successful in obtaining a Land and Water Conservation Fund (LWCF) grant in the amount of \$200,000 to partially fund these improvements; and

WHEREAS, the City issued four hundred and nine (409) electronic invitations of which there were four (4) responsive submittals received from the following contractors:

1) Imperial Electrical, Inc. (\$344,900.00); 2) Electrical Contracting Service (\$351,573.00);

3) Davco Electrical Contractors Corp. (\$378,128.00); and 4) Kilowatt Electric Company (\$390,000.00); and

WHEREAS, the Purchasing Division reviewed the bid responses for compliance and no issues were found; and

WHEREAS, staff recommends approval of this agreement with Imperial Electrical, Inc., the lowest responsive bidder; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with Imperial Electrical, Inc. to furnish and install

replacement sports lighting at Sabal Pines Park in the amount of \$351,798.00 inclusive of a two percent (2%) contingency, pursuant to Bid No. 04-15-20-11.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Imperial Electrical, Inc. to furnish and install replacement sports lighting at Sabal Pines Park in an amount not to exceed \$351,798.00.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and Imperial Electrical, Inc. and any change orders in accordance with the Purchasing Policies & Procedures Manual.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
