A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, ACCEPTING THE ACTION PLAN PROGRAM YEAR 2015 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER), ATTACHED HERETO AND MADE A PART HEROF AS EXHIBIT "A," FOR COMMUNITY PLANNING AND DEVELOPMENT PROGRAMS; AND AUTHORIZING TRANSMITTAL OF THE ACTION PLAN PROGRAM YEAR 2015 CAPER TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek is an entitlement recipient of federal funds from the U.S. Department of Housing and Urban Development (HUD) under the CDBG Program; and

**WHEREAS**, the City received \$315,847, including program income, in Community Development Block Grant (CDBG) Program funds for Action Plan Program Year 2015; and

WHEREAS, in accordance with federal regulations, the City must prepare and submit the CAPER to HUD within ninety (90) days after the close of the Program Year; and

WHEREAS, the public review draft of the CAPER was made available for a 15-day public comment period, commencing November 21, 2016, and concluding on December 5, 2016, at the Office of the City Clerk and the Department of Sustainable Development in Coconut Creek City Hall located at 4800 W. Copans Road; and

**WHEREAS,** prior to accepting the CAPER, a public hearing was held by the City Commission on December 8, 2016, in the City Commission Chambers, which was duly noticed in the Sun-Sentinel on November 20, 2016.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE **CITY OF COCONUT CREEK, FLORIDA:**

Section 1: That the foregoing WHEREAS clauses are ratified as being true and correct and are made a specific part of this Resolution.

Section 2: That the City Commission has reviewed and hereby accepts the Action Plan Program Year 2015 CAPER, attached hereto and made a part hereof as Exhibit "A," for Community Planning and Development Programs.

Section 3: That the City Commission hereby authorizes the transmittal of the Action Plan Program Year 2015 CAPER to the U.S. Department of Housing and Urban Development.
