## **RESOLUTION NO. 2017-233**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, SUPPORTING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S (FDOT) MANAGEMENT, CONSTRUCTION, AND DELIVERY OF THE LYONS ROAD MOBILITY PROJECT, FM NO. 436319-1, FROM THE C-14 CANAL TO THE SAWGRASS EXPRESSWAY IN ACCORDANCE WITH THE FDOT PROGRAM MANAGEMENT BULLETIN 15-03; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 24, 2013, the City Commission of the City of Coconut Creek approved Resolution No. 2013-112 in support of Complete Streets to allow all users, including people who walk, bike, use transit, and drive, to safely navigate our roadways; and

WHEREAS, on February 26, 2015, the City Commission of the City of Coconut Creek approved Resolution No. 2015-045 in support of the Lyons Road Mobility Project to include bicycle lanes, sidewalks, and pedestrian amenities along the Lyons Road corridor between Atlantic Boulevard and the Sawgrass Expressway; and

WHEREAS, said project has been defined as an off-system prioritized project within the local right-of-way/jurisdiction of the City of Coconut Creek not located on the State Highway System; and

WHEREAS, the Florida Department of Transportation (FDOT) is authorized to undertake the project identified as FM No. 436319-1 within Coconut Creek municipal limits; and

**WHEREAS**, a resolution to endorse FDOT's delivery of said project within the local agency's right of way/local jurisdiction is required; and

**WHEREAS,** FDOT provides for a public involvement process, and the City retains final approval of the design to be constructed.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission of the City of Coconut Creek, Florida, hereby supports FDOT's management, construction, and delivery of the Lyons Road Mobility Project identified by FDOT as FM No. 436319-1, along Lyons Road from the C-14 Canal to the Sawgrass Expressway, in accordance with FDOT's Program Management Bulletin 15-03.

**Section 3:** That the City Clerk is hereby directed to provide a copy of this Resolution to FDOT.

<u>Section 4:</u> That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

**Section 5:** That this Resolution shall be in full force and effect immediately upon its adoption.
