RESOLUTION NO. 2017-294

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY AND ZAMBELLI FIREWORKS MANUFACTURING CO. TO PROVIDE A FIREWORKS DISPLAY FOR THE BUTTERFLY FESTIVAL PURSUANT TO RFP NO. 08-30-17-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 6, 2017, the City issued a Request for Proposals (RFP) to contract with a qualified vendor to provide a professional fireworks display, approximately 25 minutes long, for the annual Butterfly Festival; and

WHEREAS, twenty-two (22) solicitations were electronically sent through the eBid System, and four responsive submittals were received; and

WHEREAS, the proposals were evaluated based on criteria stated in the RFP document, scope of services proposed, reference checks, and performance reference surveys by a selection committee consisting of Ryan Banyas, Fire Inspector; Danielle DeBarros, Assistant Director of Parks and Recreation; Ernest Fontan, Deputy Fire Marshal; Bernadette Hughes, Assistant to the City Manager; and Leonardo Moleiro, Special Events Planner; and

WHEREAS, the Selection Committee ranked Zambelli Fireworks Manufacturing Co. number one and recommends that they be awarded the contract for a Fireworks Display for the Butterfly Festival pursuant to RFP No. 08-30-17-11; and

WHEREAS, the initial contract term shall be for three (3) years with the right to extend the contract for two (2) additional one (1) year periods.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

<u>Section 2</u>: That the City Commission has reviewed and hereby approves the attached Agreement between the City of Coconut Creek and Zambelli Fireworks Manufacturing Co. to provide a Fireworks Display for the Butterfly Festival pursuant to RFP No. 08-30-17-11.

<u>Section 3</u>: That the City Manager, or designee, is hereby authorized to execute the attached Agreement between the City of Coconut Creek and Zambelli Fireworks Manufacturing Co.

<u>Section 4</u>: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

<u>Section 5</u>: That this Resolution shall be in full force and effect immediately upon its adoption.
