WITNESSETH:

WHEREAS, the parties desire to amend the Agreement between the City of Coconut Creek and the Contractor dated January 23, 2014, to provide for magazines to be printed and mailed to additional residents within the City of Coconut Creek.

NOW, THEREFORE, based on the promises and covenants herein contained, the parties agree as follows:

DETAILED REQUIREMENTS - SCOPE OF SERVICES

1. Intent

The intent of this proposal is to establish a public/private partnership with a local publishing company to design, print, and mail a monthly magazine that focuses on City news and events in accordance with the specifications contained herein. The magazine will be distributed to every household in the City.

as well as separate cost for recycled paper option.
