### **CALL TO ORDER**

Mayor Welch called the meeting to order at 7:03 p.m. and announced that Agenda Item 11 had been removed from the agenda and would not be heard tonight.

Mayor Welch asked all to rise for the Pledge of Allegiance led by the Coconut Creek Honor Guard.

## PRESENTATION(S)

**1. 19-264** A PROCLAMATION RECOGNIZING DECEMBER 12, 2019, AS "MARK BOGEN DAY."

Mayor Welch read the proclamation into the record. Broward County Commissioner Mark Bogen accepted the proclamation and thanked the Commission for the recognition. Wynmoor President Jacqueline Railey spoke and thanked Commissioner Bogen for his service to the community.

**2. 19-260** A PRESENTATION BY KAREN E. MATRONI, GENERAL MANAGER FOR THE PROMENADE AT COCONUT CREEK.

Karen Matroni, General Manager for the Promenade at Coconut Creek, shared a brief *PowerPoint* presentation highlighting anticipated capital improvements for the Promenade to provide for community gathering spaces, and spoke about the community mural project that was completed on the north garage.

3. 19-263 A PRESENTATION INTRODUCING POLICE OFFICER MICHAEL LEONARD AND K9 TAYLOR AS THE POLICE DEPARTMENT'S NEW SCHOOL SAFETY DOG AND HANDLER TEAM.

Police Chief Albert "Butch" Arenal showed a brief video introducing the Police Department's first school safety dog and handler team, K9 Taylor and Police Officer Michael Leonard, to enhance safety in Coconut Creek schools. He spoke about the Vapor Wake K9 Academy, where the team was trained, and Officer Leonard briefly addressed the Commission.

**4. 19-261** A CEREMONY RECOGNIZING THE PROMOTION OF POLICE OFFICER ROGER HALL TO SERGEANT.

Police Chief Arenal introduced Sergeant Hall and invited him and his family to come forward for the badge pinning ceremony.

#### INPUT FROM THE PUBLIC

Lauren Linville, 7124 NW 47 Lane, Coconut Creek, spoke about an engagement committee formed by the residents of the Hidden Lake, Secret Pond, and Pinecreek communities in response to the rezoning request for the Vista Gardens project, commenting that the communities were not in favor of the rezoning. She advised that the committee met with the developers to discuss the project and both the developers and committee members wished to meet with City staff to discuss the next steps.

Artur Amaral, 5006 Pinecreek Place, Coconut Creek, Pinecreek Homeowners' Association President, asked the Commission to review the rezoning requirements in the City's Code before a decision was made on the Vista Gardens project.

Atlantic Technical High School students Cayla Rucker and Jaanai Scott shared a brief *PowerPoint* presentation regarding Terra, the business they formed for the Junior Achievement Fellows Program. They explained that Terra is an eco-friendly company that sells an eco-friendly bracelet inspired by the monarch butterfly.

Mayor Welch implemented the Time Certain, and the City Manager Report, City Attorney Report, and Commission Communications were heard after the Regular Agenda.

#### **CITY MANAGER REPORT**

City Manager Brooks reported that the Broward County School Board advised that the school safety dog, K9 Taylor, would not be allowed into the schools unless a Memorandum of Understanding (MOU) was in place. She commented that staff was expeditiously working on the MOU. Discussion ensued regarding the School Board's decision to require the MOU after first advising it would not be required, and negotiating the terms of the MOU.

City Manager Brooks wished everyone happy holidays and a happy new year.

# **CITY ATTORNEY REPORT**

City Attorney Pyburn wished everyone happy holidays and a happy new year.

Assistant City Manager / Sustainable Development Director Sheila Rose gave a brief update from the Commerce Center of Coconut Creek Association meeting that she attended as the City's proxyholder. She noted that the purpose of the meeting was to turn over representation from the Seminole's control to the property owners' association, and commented that only two property owners were present, the City of Coconut Creek and the Seminole Tribe of Florida. She stated that the City would be responsible

for the maintenance of the 10-acre parcel owned by the City within the Commerce Center of Coconut Creek and participate in the required improvements to the property.

## **COMMISSION COMMUNICATIONS**

Commissioner Tooley spoke about the School Board's decision to not allow K9 Taylor into the schools without an MOU. She spoke about the Police Department's Vacation Watch Program.

Commissioner Belvedere attended a meeting in Wynmoor regarding the Florida Department of Transportation's (FDOT) plan to widen the Turnpike and thanked City Manager Brooks and Assistant City Manager Rose for attending. She noted that the Wynmoor community provided FDOT with over 700 petitions objecting to the project. She attended the Sugar Pops Orchestra music event at the Township Community Center and the Northwest Council of Elected Officials meeting hosted by the City of Coral Springs where they discussed public art. She spoke about the Lyons Road Mobility Improvement Project. She announced that the Broward Metropolitan Planning Organization (MPO) was hosting a workshop to discuss strategies for implementing surtax funding. She wished everyone a happy holiday season.

Vice Mayor Sarbone spoke about the special events hosted by the Promenade, including the tree lighting ceremony, and thanked them for being good community partners. He wished every happy holidays and a happy new year.

Mayor Welch spoke about the workshops and tours she participated in at the National League of Cities City Summit conference in San Antonio, Texas. She wished everyone a wonderful holiday.
