

RESOLUTION NO. 2025-190

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND THOR GUARD, INC. FOR THE SINGLE SOURCE PURCHASE OF LIGHTNING PREDICTION AND WARNING SYSTEMS FOR A THREE (3) YEAR PERIOD; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, for over twenty (20) years, the City has been using Thor Guard equipment for its lightning prediction and warning systems; and

WHEREAS, these systems are located throughout the City's parks and facilities to warn the public about the potential for lightning strikes in the area; and

WHEREAS, updates to the City's Thor Guard systems are necessary to ensure that they are utilizing the latest technology available; and

WHEREAS, the City budgeted capital outlay funds in Fiscal Year 2025 (FY25) to upgrade its lightning prediction systems; and

WHEREAS, Thor Guard provided the following four (4) proposals to complete this work: Sabal Pines Park - \$27,520.00; Community Center - \$27,555.00; Recreation Complex - \$24,605.00; and Public Works - \$26,455.00 for a total cost of \$106,135.00; and

WHEREAS, City staff is seeking approval to list Thor Guard, Inc. as a single source for lightning prediction and warning systems and any necessary repairs or replacements for a three (3) year period; and

WHEREAS, City staff is also seeking approval to upgrade the four (4) noted stations for a total expenditure of \$106,135.00; and

WHEREAS, the City Commission of the City of Coconut Creek finds it to be in the best interest of the City to execute the attached agreement between the City of Coconut Creek and Thor Guard, Inc. for single source purchases of lightning prediction and warning systems.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Thor Guard, Inc. for single source purchases of lightning prediction and warning systems.

Section 3: That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Thor Guard, Inc. for single source purchases of lightning prediction and warning systems.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
