My name is Van Hamlin and I live at 5050 NW 54 Street, Coconut Creek, FI 33073. You may contact me at 954-895-5920. My wife, Sandra, and I own our home and have lived in Creek for about 30 years. I am retired from BSO and my still works for HCA - Parlon. N. W. Regional Hospital is one of their facilities. Obviously, EMS and Fire Rescue deal directly with this medical center. I am also a Board Member for Cypress Lakes H.O.A. We have approximately 166 residences which account for 332 votes.

I am asking you to approve the proposed increase in assessment BUT suspend it's implementation until at least March of the 2022 fiscal year. I feel that inflation has skyrocketed along with COVID-19 Delta, which is making it difficult for many home owners who are now having a tough time making ends meet. Unemployment has increased dramatically, as well. Many local landlords are being punished by having to continue to pay mortgages while their tenants have avoided paying their rents. Without your foresight, many rental properties will eventually be repossessed unless we help the small business owners and private landlords. All of these crisis have resulted in the devaluation of the dollar. In short, we have entered hard economic times where many of our residents may loose their homes without your assistance. These hard times will have a long term regressive influence on tax revenue.

In the short term, You might transfer money from other budgets, such as parks and recreation, to cover any shortfalls. I use this example because our community should not be sponsoring events where people congregate right now. While parks may be left open, they do not have to be attended. The police and fire department can make routine inspections and patrol these areas. A layoff of these staff members may be indicated. Other departments, not directly involved with public safety should be put on rotating furlows, if needed to make up any shortfalls in funding current levels of service by Fire rescue.

To Whom It May Concern,

We just received a Notice of Public Hearing. The differential in rate per parcel for Industrial/Warehouse vs. Commercial/Office/Institutional is absurd, flawed, and completely not equitable. We own a large property in Coconut Creek and year-after-year, we pay the annual special assessment for fire rescue protection services. Last year, we converted the property to a condominium structure and sold the rear of the property to our former bakery tenant. Based upon the proposed assessment, the front parcel which we retained will be charged 10x the amount as the rear. This is completely illogical and unequitable. Why should a smaller parcel with a yoga studio, furniture store, imaging center and surgical center pay ten times the amount as a fully operating bakery with ovens and other fire hazards onsite? Fire assessments should be based upon use and risk. The Notice clearly states that the proposed assessments allocate based upon historic fire rescue incident reports, property size, and property value. However, despite this assertion, the allocation methodology fails to achieve this end. Not only is the allocation not equitable, but it poses an undue burden on local operators serving the Coconut Creek community.

I am writing to vehemently object to the annual special assessment proposed against my property. I understand that the cost needs to be spread amongst property owners, but the allocation proposed is flawed, completely unequitable and discourages ownership in the city of Coconut Creek. I am not aware of any other municipality that imposes such an unequitable and onerous burden on property owners. Please reconsider the rate allocation to achieve greater equity.
