

RESOLUTION NO. 2018-089

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A WORK AUTHORIZATION FOR ARCHITECTURAL DESIGN SERVICES TO BE PROVIDED BY WALTERS ZACKRIA ASSOCIATES, INC. RELATED TO THE REPLACEMENT OF THE GOVERNMENT CENTER ROOF; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has determined that the Government Center roof is in need of replacement; and

WHEREAS, the City Commission approved funding in the FY18 Capital Improvement Program to replace the Government Center roof; and

WHEREAS, architectural services are necessary to design and permit these improvements; and

WHEREAS, Walters Zackria Associates, Inc. was selected and approved to be included in the City's pool of qualified consultants pursuant to RFQ No. 08-24-16-11 entitled, "Architecture, Landscape Architectural and Urban Design Services;" and

WHEREAS, staff obtained a proposal from Walters Zackria Associates, Inc. to provide the aforementioned design services in the amount of \$87,790; and

WHEREAS, staff has reviewed the proposal and considers the fees to be fair and reasonable; and

WHEREAS, the City Commission finds it to be in the best interest of the residents of the City to approve a Work Authorization with Walters Zackria Associates, Inc. for architectural design services for the replacement of the Government Center Roof.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

Section 2: That the City Commission has reviewed and hereby approves the Work Authorization between the City of Coconut Creek and Walters Zackria Associates, Inc. for architectural design services related to the replacement of the Government Center roof.

Section 3: That the City Manager, or designee, is hereby authorized to execute the aforementioned Work Authorization between the City of Coconut Creek and Walters Zackria Associates, Inc. in the amount of \$87,790.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
