## **RESOLUTION NO. 2023-126**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND WEEKLEY ASPHALT, INC. FOR THE RELOCATION AND REPLACEMENT OF CITY HYDRANTS AND VALVES ON COPANS ROAD; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek (City) owns and maintains City utilities along Copans Road within Broward County (County) right-of-way; and

**WHEREAS**, the County is improving the Copans Road right-of-way and has requested the relocation of City hydrants and valves that are impeding the expansion of the roadway; and

**WHEREAS,** the City's hydrants and valves, located within the County's proposed work zone, are due for replacement; and

**WHEREAS**, the City desires to enter into an agreement with Weekley Asphalt Paving, Inc. to relocate and replace, in concurrence with the County's roadway improvement project, all conflicting hydrants and valves, as well as roadway restoration for a lump sum amount of \$229,775.00; and

**WHEREAS**, Weekley Asphalt Paving, Inc. is the awarded contractor for the County's Copans Road Improvement Project and has the resources and capability to complete the relocation and replacements to eliminate any delays and minimize conflicts with the County's roadway improvement project; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with Weekley Asphalt Paving, Inc. for the relocation and replacement of the City's hydrants and valves on Copans Road in the amount of \$229,775.00.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Weekley Asphalt Paving, Inc. for the relocation and replacement of hydrants and valves on Copans Road, as well as roadway restoration in the amount of \$229,775.00.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Weekley Asphalt Paving, Inc.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
