RESOLUTION NO. 2023-133

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ROSTAN SOLUTIONS. LLC TO **PROVIDE EMERGENCY DEBRIS MONITORING SERVICES** PURSUANT TO RFP NO. 05-24-23-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City is aware that the services of an emergency debris monitoring firm are necessary for attaining FEMA and/or FDOT or other regulatory agency reimbursement in the event of a disaster; and

WHEREAS, the City issued fifty-five (55) electronic invitations through the eBid System on April 23, 2023, and six (6) vendors submitted a complete response: 1) Debris Tech, LLC, 2) Disaster Program & Operations, 3) Rostan Solutions, LLC, 4) Tidal Basin Government Consulting, LLC, 5) Tetra Tech, Inc., and 6) Thompson Consulting Services, LLC; and

WHEREAS, a selection committee consisting of Harry Mautte, Public Works Director; Alex Tergis, Public Works Assistant Director; and Brian Rosen, Project Manager, evaluated the submittals based on the criteria listed in the Request for Proposals (RFP) document; and

WHEREAS, after an extensive evaluation process, which included the review of each firm's price, operational plan for the City, qualifications and experience, resources and availability, references, and past performance, and presentations, the selection committee is recommending that Rostan Solutions, LLC be awarded the contract for this service; and

WHEREAS, the initial contract period shall be for four (4) years, beginning upon City Commission approval; and

WHEREAS, the City reserves the right to extend the contract for two (2) additional one (1) year periods, providing both parties agree to the extension; all terms, conditions and specifications remain the same; and such extension is approved by the City; and

WHEREAS, the City Commission finds and determines that it is in the best interest of the City to enter into an agreement with Rostan Solutions, LLC to provide emergency debris monitoring services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreement, attached hereto and made a part hereof, between the City of Coconut Creek and Rostan Solutions, LLC to provide emergency debris monitoring services pursuant to RFP No. 05-24-23-11.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the agreement, attached hereto and made a part hereof, between the City of Coconut Creek and Rostan Solutions, LLC for emergency debris monitoring services pursuant to RFP No. 05-24-23-11.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
