A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, RATIFYING THE INTERLOCAL AGREEMENT BETWEEN **BROWARD** COUNTY AND THE CITY OF COCONUT CREEK PROVIDING FOR FUNDING AND ADMINISTRATION OF FISCAL YEARS 2020-2024 CARES ACT COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG-CV) AND COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) (CFDA #14.218 / FAIN # B-20-MW-12-B-21-UC-12-0001, 0054. B-22-UC-12-0001) REIMBURSEMENT OF THE RECREATION COMPLEX HVAC REPLACEMENT PROJECT; PROVIDING FOR SEVERABILITY: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City is designated as an entitlement community pursuant to 24 C.F.R Part 570.4, with a population in excess of 50,000, entitling the City to receive Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD) and implement its own CDBG programs; and

WHEREAS, on September 27, 2007, the City Commission of the City of Coconut Creek approved a motion to accept the City as an entitlement grantee of federal funds from HUD and the responsibilities associated with that status; and

WHEREAS, HUD encourages the establishment of joint local housing assistance programs, and authorizes local governments to enter into interlocal agreements (ILA) to establish and implement such programs; and

WHEREAS, the City of Coconut Creek and Broward County entered into an Urban County Cooperation Agreement on August 27, 2020, for Broward County to prepare, implement, and administer the City's allocations of CDBG Program funding; and

WHEREAS, the City of Coconut Creek and Broward County have entered into associated ILAs for Program Year-specific allocations, including CARES Act allocations for CDBG coronavirus response (CDBG-CV) funding; and

WHEREAS, the City of Coconut Creek entered into an agreement on April 13, 2023, with Master Mechanical Services, Inc., authorizing the utilization of CDBG funds for the Recreation Complex HVAC Replacement Project; and

WHEREAS, on July 22, 2024, the City Manager executed an ILA with Broward County for administration of the City's Program Year 2020-2024 CDBG-CV and CDBG funding for completion of the Recreation Complex HVAC Replacement Project, as the City was required to execute the ILA on or before July 31, 2024 necessary for reimbursement; and

WHEREAS, the City Commission finds and determines that the City Manager's execution of the ILA for the administration of the City's Program Year 2020-2024 CDBG-CV and CDBG funding for completion of the Recreation Complex HVAC Replacement Project to be in the best interest of the residents of the City of Coconut Creek and hereby ratifies the ILA.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby ratifies the attached agreement between Broward County and the City of Coconut Creek for the preparation, implementation, and administration by the County for the City's 2020-2024 CDBG-CV and CDBG funding for completion of the Recreation Complex HVAC Replacement Project.

<u>Section 3:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 4: That this resolution shall be in full force and effect immediately upon its adoption.
