

RESOLUTION NO. 2019-183

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND POWERCORE, INC. TO PROVIDE FOR THE INSTALLATION OF PEDESTRIAN LIGHTING ON COCONUT CREEK PARKWAY BETWEEN LYONS ROAD AND COCONUT CREEK BOULEVARD PURSUANT TO BID NO. 06-19-19-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission approved funding in the Capital Improvement Program budget for the installation of pedestrian lighting along the north and south sides of Coconut Creek Parkway between Lyons Road and Coconut Creek Boulevard; and

WHEREAS, the City issued Bid No. 06-19-19-11 entitled “Coconut Creek Parkway Pedestrian Lighting,” through the e-bid system for the purpose of identifying a qualified and experienced contractor to install the aforementioned pedestrian lighting; and

WHEREAS, the City received seven (7) bid submittals of which five (5) were deemed to be responsive; and

WHEREAS, after careful review of the bid submittals, including references and past experience on projects of similar scope and value, staff recommends approval of an agreement with PowerCore, Inc., the lowest responsible and responsive bidder, in the amount of \$584,771.70 for the aforementioned purpose; and

WHEREAS, the City Commission finds and determines that it is in the best interest of the City to enter into an agreement with PowerCore, Inc. for the purpose of installing pedestrian lighting along the north and south sides of Coconut Creek Parkway between Lyons Road and Coconut Creek Boulevard in the amount of \$584,771.70.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and PowerCore, Inc. for the purpose of installing pedestrian lighting on Coconut Creek Parkway pursuant to Bid No. 06-19-19-11 in the amount of \$584,771.70.

Section 3: That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and PowerCore, Inc. for the aforementioned purpose.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
