

RESOLUTION NO. 2019-293

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPROVING THE WINSTON PARK FOUNDATION APPLICATION FOR MATCHING FUNDS FROM THE NEIGHBORHOOD ENHANCEMENT GRANT PROGRAM FOR LANDSCAPING ENHANCEMENTS ALONG HILTON ROAD; PROVIDING FOR CONDITIONS OF APPROVAL; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek has funded a Neighborhood Enhancement Grant Program to provide matching funds for enhancements to the City's neighborhoods and communities; and

WHEREAS, the Winston Park Foundation community has applied for \$20,000 in matching funds from the Neighborhood Enhancement Grant Program for landscape enhancements along the Hilton Road neighborhood entrance; and

WHEREAS, Winston Park Foundation has retained services from Top Cut Lawn Services for design and installation; and

WHEREAS, the Neighborhood Enhancement Grant Program provides for reimbursement up to \$20,000; and

WHEREAS, the Winston Park Foundation will provide matching funds for design and installation; and

WHEREAS, the Winston Park Foundation has agreed to be responsible for the maintenance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this

resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission hereby approves the Winston Park Foundation application for \$20,000 in matching funds for enhancements to the neighborhood entrance landscaping along Hilton Road.

Section 3: That the Winston Park Foundation is responsible for providing matching funds for the design, installation, and maintenance of landscaping along the Hilton Road neighborhood entrance.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
