

**RESOLUTION NO. 2024-095**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND SUPERSPORTS OF BROWARD COUNTY, INC. TO PROVIDE SPORTS OFFICIATING SERVICES PURSUANT TO RFP NO. 04-29-24-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, sports officials fill the critical role of making sure athletic sports leagues are fairly played and well-managed in a safe environment for all participants and spectators; and

**WHEREAS**, on April 7, 2024, the City issued Request for Proposals (RFP) No. 04-29-24-11 to contract with a qualified firm to provide sports officiating services for the City's recreational sports leagues, including furnishing all labor, service and supervision necessary to properly officiate sports events in a safe, effective, and efficient manner on an as-needed basis; and

**WHEREAS**, on April 29, 2024, the City received proposals from three (3) firms: 1) Team Services Florida, LLC; 2) SuperSports of Broward County, Inc.; and 3) 4life Resource & Services, LLC; and

**WHEREAS**, the proposal submitted by 4life Resource & Services, LLC was determined to be non-responsive due to not submitting required documents; and

**WHEREAS**, after reviewing the remaining proposals, a selection committee consisting of Priya Ragoonanan, Finance and Administrative Services Accountant; Colette Okamoto, Parks and Recreation Supervisor; and Melissa See, Parks and Recreation Supervisor, determined that SuperSports of Broward County, Inc. submitted a responsive and responsible proposal; and

**WHEREAS**, the initial contract period will begin following approval of this resolution

and full execution of the agreement, attached hereto and made a part hereof as “Exhibit 1,” and will expire three (3) years from that date; however, the City may extend the contract for two (2) additional one (1) year periods, providing each party agrees to the extension under the same terms, conditions, and specifications; and

**WHEREAS**, the City Commission finds and determines it to be the best interest of the City to enter into an agreement with SuperSports of Broward County, Inc. for sports officiating services.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. The agreement, attached as “Exhibit 1,” is incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and SuperSports of Broward County, Inc. for sports officiating services pursuant to RFP No. 04-29-24-11.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and SuperSports of Broward County, Inc.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
