RESOLUTION NO. 2020-026

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND VISUALSCAPE, INC. FOR STATE ROAD 7 MEDIAN BEAUTIFICATION PURSUANT TO BID NO. 01-08-20-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the purpose of the Invitation for Bid is to contract with a qualified Florida Department of Transportation (FDOT) approved Landscape Contractor to enhance the State Road 7 medians from Cullum Road to just south of the Sawgrass Expressway; and

WHEREAS, the project consists of the installation of an irrigation system, decorative brick pavers, trees, shrubs, groundcover, and sod; and

WHEREAS, the City was successful in obtaining a Florida Highway Beautification Council Grant in the amount of \$100,000 to partially fund these improvements; and

WHEREAS, the City of Coral Springs has agreed to share in the ongoing maintenance costs; and

WHEREAS, on December 1, 2019, the City issued one hundred seventy eight (178) electronic invitations of which there were six (6) responsive submittals received from the following contractors: 1) VisualScape, Inc. (\$486,702.35); 2) Landscape Service Professionals, Inc. (\$529,148.00); 3) MBR Construction, Inc. (\$647,640.00); 4) Green Construction Technologies, Inc. (\$648,982.00); 5) Arazoza Brothers Corp. (\$687,105.70); and 6) SFM Services, Inc. (\$706,131.55); and

WHEREAS, the Purchasing Division reviewed the bid responses for compliance and no issues were found; and

WHEREAS, staff recommends approval this agreement with VisualScape, Inc., the lowest responsive bidder; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with VisualScape, Inc. to enhance the State Road 7 medians from Cullum Road to just south of the Sawgrass Expressway in the amount of \$486,702.35, pursuant to Bid No. 01-08-20-11.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and VisualScape, Inc. to enhance the State Road 7 medians from Cullum Road to just south of the Sawgrass Expressway.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and VisualScape, Inc. and any Change Orders in accordance with the Purchasing Policies & Procedures Manual.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
