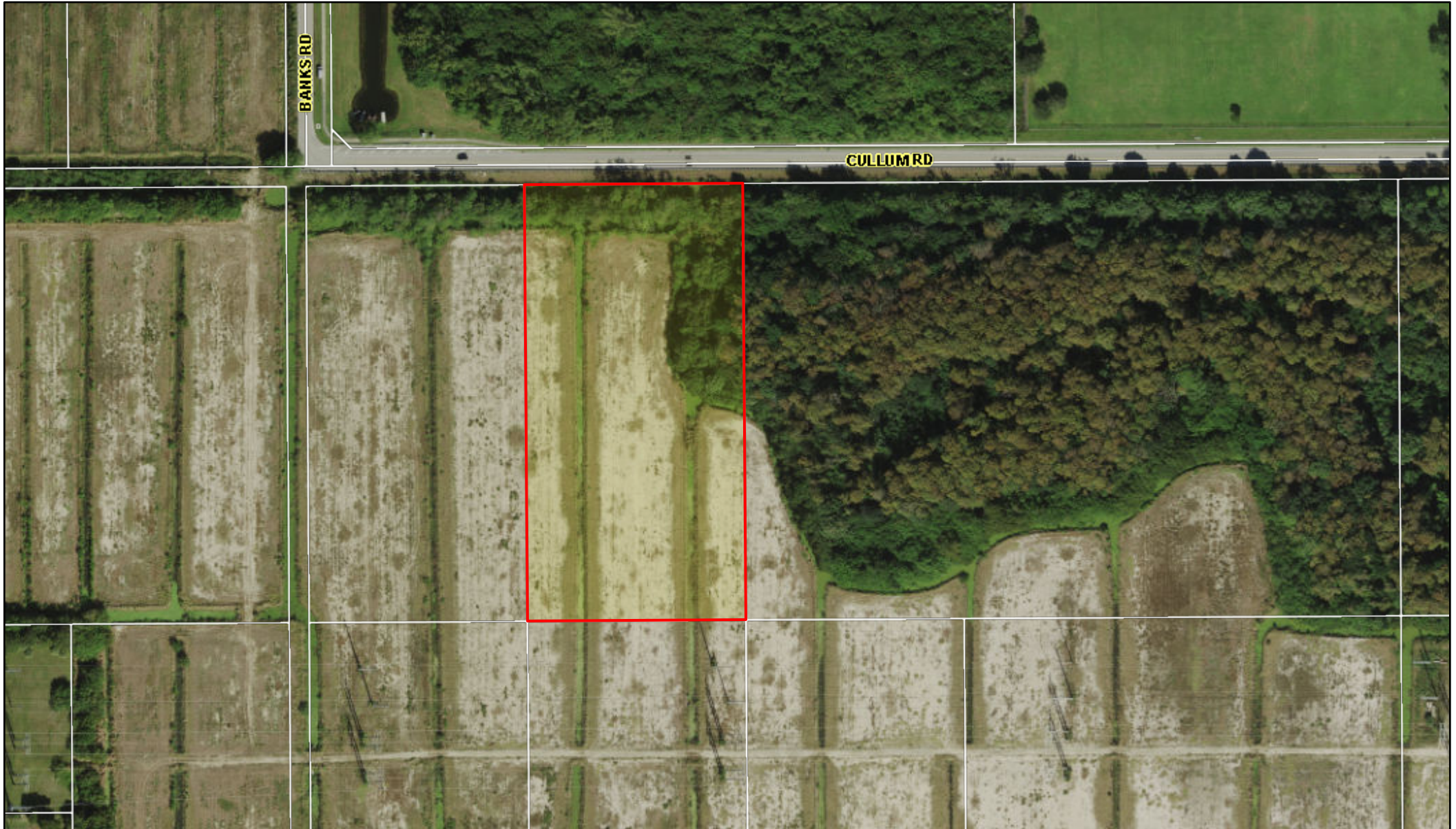

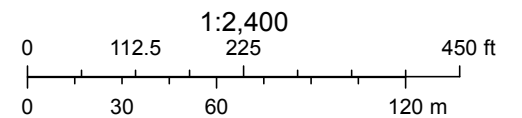

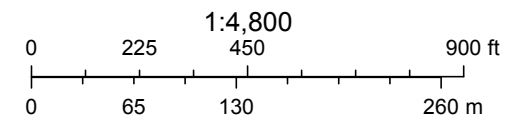

CORRECTIVE QUIT CLAIM DEED

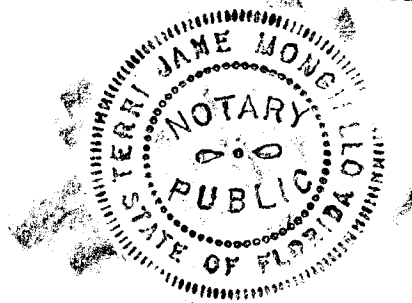

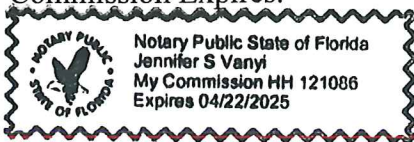

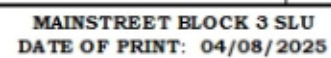

The Property has a future land use designation of Regional Activity Center (“RAC”) and is currently zoned PMDD, MainStreet Planned Development District. Petitioner is proposing to develop the Property with a mixed-use project that includes a variety of residential dwellings, commercial uses and open space (“Project”).

On August 26, 2010, the City adopted Ordinance 2006-006 approving the Mainstreet @ Coconut Creek DRI (“DRI Development Order”) for the Property. The DRI Development Order provides approval for the following uses, subject to site plan review and approval demonstrating that the actual mix of residential, office, and commercial uses proposed is consistent with the City’s Mainstreet Design Standards:

- Commercial Uses: 1,625,000 square feet of gross floor area
- Office Uses: 525,000 square feet of gross floor area
- Residential: 3,750 residential units.

The City recently approved a DRI Amendment and PMDD Rezoning Application in order to allow for the Project. The PMDD Rezoning application proposes the following maximum development program:

- 540 Villas and Townhomes with a maximum of 2-stories;
- 880 Multifamily Units with a maximum of 5-stories;
- 875 Multifamily Units with a maximum of 8-stories;
- 105,000 square feet of Commercial Use;
- 15,000 square feet of private recreation; and
- City Civic space.

At this time, Petitioner is seeking Special Land Use approval for the drive through facility located within Block 3 of the PMDD. More specifically, Block 3 is a +/- 9.78 acre parcel generally located at the southwest corner of 40th Street and Lyons Road. On August 8, 2024, the City Commission approved Resolution 2024-109 approving development of Block 3 with approximately 67,366 square feet of commercial uses including eight (8) commercial buildings as follows:

- A +/- 9,000 square foot inline retail building (Retail A) situated perpendicular to 40th Street in the western portion of the parcel across from Johns Park,
- A +/- 14,100 square foot inline retail building (Retail B) located south of Retail A with a wide pedestrian paseo integrating the buildings,
- A +/- 7,000 square foot outparcel retail building (Retail D) located at the southeast corner of the parcel including a +/- 2,800 square foot drive through facility,
- A +/- 7,800 square foot outparcel retail building (Retail E) located across the southern driveway to the north of Retail D and oriented to provide a building façade along the Lyons Road greenway,
- A +/- 6,000 square foot outparcel retail building (Retail F2) located north of Retail E with a pedestrian paseo integrating the buildings and oriented to provide a building façade along the Lyons Road greenway,
- A +/- 6,000 square foot outparcel retail building (Retail F1) located north of Retail F2 with a pedestrian plaza integrating the buildings and oriented to provide a building façade along the Lyons Road greenway,
- A +/- 6,600 square foot outparcel retail building (Retail G) located across the northern driveway north of Retail F1 and oriented to provide a building façade along the Lyons Road greenway, and
- A +/- 7,800 square foot outparcel retail building (Retail H) located along 40th Street adjacent to the perimeter greenway to the west of Building G with a pedestrian plaza situated at the northeast corner to integrate Building G and H.

As shown on the approved site plan, there is a +/- 2,800 square foot Drive Through Facility proposed in the 7,000 square foot Retail D building located at the southeast corner of Block 3. A Drive Through is a Special Land Use in accordance with the Master Business List for a PMDD. As such, Petitioner respectfully requests approval for a Special Land Use for the Drive Through Facility located in Retail D of Block 3.

Although it is not possible to identify the tenant at this time, and it is critical to the success of the leasing strategy for this commercial center that there be some flexibility in the end use, the

applicant is committed to ensuring that the drive thru use is operated only by a quality tenant that does not create adverse impacts for the center, community, or the surrounding road network. To that end, the applicant proposes to limit the use of the space to “Fast Casual Restaurant” or “Coffee Shop” uses, which will be defined as follows for purposes of the proposed restriction:

“Fast Casual Restaurant” shall mean a restaurant with no (or very limited) wait staff or table service. A customer typically orders by walking up to a counter, fax, online, or in the drive thru, and seats themselves. The menu generally contains higher-quality, made-to-order food items with fewer frozen or processed ingredients than at a fast-food restaurant, or allows the customer to create their own meal by selecting individual items/ingredients from a list of pre-cooked options including but not limited to bases (i.e. greens, rice, starch), vegetables, proteins (i.e. chicken, steak, fish, tofu), toppings, and sauces. Most patrons eat their meal within the restaurant, but a significant proportion of the restaurant sales can be carry-out, mobile pickup, or drive-thru orders. A fast casual restaurant typically serves lunch and dinner; some serve breakfast. A typical duration of stay for an eat-in customer is 40 minutes or less. Typical Fast Casual Restaurants include, but are not limited to Just Salad, Chipotle, Cava, Habit Burger, Panera, Sweet Green, etc. The following are examples of non-fast casual restaurants: McDonalds, Taco Bell, Wendy’s, Burger King, Chick Fil A, etc.

“Coffee Shop” shall mean a coffee and donut restaurant that has a drive-through window as well as a walk-in entrance area at which a patron can purchase and consume items. The restaurant sells freshly brewed coffee (along with coffee-related accessories) and a variety of food/drink products such as donuts, bagels, breads, muffins, cakes, sandwiches, wraps, salads, and other hot and cold beverages.

It is also important to note that the traffic impact analysis for the requested Special Land Use contemplates the most intensive trip generation of any type of restaurant. The highest peak hour trip generation rate is for a coffee shop with drive-through; therefore, this rate was used even though the tenant is not known and may be a different category of drive-through restaurant.

SPECIAL LAND USE STANDARDS

In accordance with Section 13-35(f) of the City Code, Petitioner will demonstrate below that the Special Land Use will: (1) be in harmony with nearby uses permitted under Article III of this chapter; (2) be in harmony with nearby existing uses; (3) be compatible with surrounding and adjacent uses in its function, its hours of operation, the type and amount of traffic to be generated, the building size and setbacks, and its relationships to the land values; (4) be in the best interests of the City, the convenience of the community, the public welfare, and be a substantial improvement to the property in the immediate vicinity; (5) contribute to the economic stability of the community; (6) not decrease public benefit or increase undesirable impacts other than those resulting from use of the site as permitted by right under Article III of this chapter or some other special land use permitted on the site; (7) not result in more intensive development than what is

approved by the land use element of the comprehensive plan; and (8) be consistent with goals, objectives, and policies of the comprehensive plan.

- (1) The proposed special land use will be in harmony with nearby uses permitted under Article III of the Land Development Code.

The proposed drive through facility is in harmony with nearby permitted uses. As detailed above, the proposed drive through is located within the MainStreet PMDD. More specifically, the proposed drive through is located within Retail D, and located at the southeast corner of Block 3 in close proximity to the heavily travelled Lyons Road thoroughfare, which is an ideal location for a drive through facility. The drive through was contemplated with the MainStreet PMDD Master Plan and Block 3 Site Plan approvals and the site plan is designed to be in harmony with the nearby permitted uses. The permitted commercial uses within Block 3 and existing self-service storage and gas station uses located to the south are consistent and compatible with the proposed drive through use. As such, the proposed special land use will be in harmony with nearby permitted uses.

- (2) The proposed special land use will be in harmony with nearby existing uses.

The proposed drive through facility is in harmony with nearby existing uses. As detailed above, the proposed drive through is located within the MainStreet PMDD. More specifically, the proposed drive through is located within Retail D, and located at the southeast corner of Block 3 in close proximity to the heavily travelled Lyons Road thoroughfare, which is an ideal location for a drive through facility. The drive through was contemplated with the MainStreet PMDD Master Plan and Block 3 Site Plan approvals and the site plan is designed to be in harmony with the nearby permitted uses. The permitted commercial uses within Block 3 and existing self-service storage and gas station uses located to the south are consistent and compatible with the proposed drive through use. As such, the proposed special land use will be in harmony with nearby existing uses.

- (3) The proposed special land use must be reasonably compatible with surrounding and adjacent uses in its function, its hours of operation, the type and amount of traffic to be generated, the building size and setbacks, and its relationships to the land values.

The proposed drive through facility is compatible with surrounding and adjacent uses. The drive through hours of operation will comply with City Code regulations and be consistent with typical drive through business hours (limited to 5:00 AM to 2:00 AM), which are compatible with the surrounding businesses and convenient for area residents. The type and amount of traffic that will be generated by the drive through facility is compatible with the commercial uses that Block 3 is designed to accommodate. The highest peak hour trip generation rate is for a coffee shop with drive-through; therefore, this rate was used even though the tenant is not known and may be a different category of drive-through restaurant. As such, the maximum potential impact has been accounted for in the design of the drive through facility. It is

also important to note that the drive through facility significantly exceeds the City's minimum queuing requirements. The City requires a minimum of six (6) eighteen foot (18') long queueing spaces, which requires 108 feet of queueing. As illustrated on the site plan, there is 185 feet of queuing from the menu board to the first point of conflict, thus providing ten (10) queuing spaces before the menu board, which exceeds the minimum code requirement by four (4) queuing spaces. An additional +/- 106 feet of queuing is provided from the menu board to the pickup window, thus providing an additional five (5) queuing spaces for a total of fifteen (15) queuing spaces. This is 2.5 times the code minimum required. As such, no queuing issue is anticipated. Further, Retail D is designed to provide additional setback and buffering from Lyons Road to ensure no negatives visual impacts to the surrounding area. As such, the proposed drive through will be compatible with the surrounding area, create a convenient option for residents, and have a positive impact on land values.

- (4) The proposed special land use will be in the best interests of the City, the convenience of the community, the public welfare, and be a substantial improvement to the property in the immediate vicinity.

The proposed drive through facility is in the best interests of the City, convenience of the community, public welfare, and a substantial improvement to the immediate vicinity. The drive through facility will only enhance the availability of convenient dining options for adjacent property owners and the community. The approved Block 3 site plan was thoughtfully designed to provide a wider landscape buffer along Lyons than elsewhere throughout the development and to place the proposed drive through pickup window on the north side of Retail D to screen the use. Considering the foregoing, the proposed drive through will be in the best interests of the City.

- (5) The proposed special land use will contribute to the economic stability of the community.

The proposed drive through facility will contribute to the economic stability of the community. The Property is currently vacant and underutilized, and the proposed drive through is a key component to providing diverse commercial uses within Block 3 and promoting the long term viability of the MainStreet development. The proposed drive-through facility will further contribute to economic stability of the community by adding a commercial property to the City's tax roll.

- (6) The proposed special land use will not decrease public benefit or increase undesirable impacts other than those resulting from use of the site as permitted by right under Article III of chapter 13 or some other special land use permitted on the site.

The proposed drive through facility will not decrease public benefit or increase undesirable impacts other than those resulting from use of the Property as permitted by right or for another special land use. As detailed above, the proposed drive through is located within the MainStreet PMDD. More specifically, the proposed drive through is located within Retail D, and located at the southeast corner of Block 3 in close

proximity to the heavily travelled Lyons Road thoroughfare, which is an ideal location for a drive through facility. The drive through was contemplated with the MainStreet PMDD Master Plan and Block 3 Site Plan approvals and the site plan is designed ensure that the drive through use operates safely and efficiently within Block 3 with appropriate buffering, screening, and bypass facilities, while also providing an additional convenient dining option to the surrounding community. As such, the proposed drive through will only increase the public benefit and improve the serves as a benefit to the area.

- (7) The proposed special land use will not result in more intensive development than what is approved by the land use element of the comprehensive plan.

The proposed drive through facility will not result in more intensive development than allowed by the Comprehensive Plan. As detailed above, the proposed drive through is located within the recently approved MainStreet PMDD and was previously contemplated as a part of the PMDD Master Plan and Block 3 Site Plan approvals. The type and amount of traffic that will be generated by the drive through facility is compatible with the commercial uses that Block 3 is designed to accommodate. The highest peak hour trip generation rate is for a coffee shop with drive-through; therefore, this rate was used even though the tenant is not known and may be a different category of drive-through restaurant. As such, the maximum potential impact has been accounted for in the design of the drive through facility. The Property will remain within the PMDD zoning, which is consistent and compatible with surrounding uses and within the maximum intensity allowed by the Comprehensive Plan.

- (8) The proposed special land use will be consistent with goals, objectives, and policies of the comprehensive plan.

The proposed drive through facility is consistent with the goals, objectives, and policies of the Comprehensive Plan. The MainStreet PMDD, inclusive of the proposed drive through facility, were previously determined to be compliant with the City's Comprehensive Plan.

In addition, in accordance with Section 13-35(g) of the City Code, Petitioner will demonstrate below that the Special Land Use will: (1) not reduce the level of service provided on any street to a lower level than would result from a development permitted by right; (2) not result in a significantly greater amount of through traffic on local streets than would result from a development permitted by right; (3) not require extension or enlargement of the thoroughfare system at a higher net public cost than would result from a development permitted by right; (4) not require enlargement or alteration of utility facilities, drainage systems, and other utility systems other than what would result from a development permitted by right; (5) not demand greater municipal public safety services exceeding the demand resulting from a development permitted by right; and (6) is appropriate given the adequacy of proposed buffers and setbacks and the land uses of surrounding properties.

- 1) The proposed use will not reduce the level of service provided on any street to a lower level than would result from a development permitted by right.

The proposed drive through use was analyzed for traffic impacts at the time of PMDD Master Plan Approval and Block 3 Site Plan Approval, and will not reduce the approved level of service provided on any street than would result from a development permitted by right. The type and amount of traffic that will be generated by the drive through facility is compatible with the commercial uses that Block 3 is designed to accommodate. The highest peak hour trip generation rate is for a coffee shop with drive-through; therefore, this rate was used even though the tenant is not known and may be a different category of drive-through restaurant. As such, the maximum potential impact has been accounted for in the design of the drive through facility.

- 2) The proposed use will not result in a significantly greater amount of through traffic on local streets than would result from a development permitted by right.

The proposed drive through use was analyzed for traffic impacts at the time of PMDD Master Plan Approval and Block 3 Site Plan Approval, and will not result in significantly greater through traffic on local streets than would result from a development permitted by right. The type and amount of traffic that will be generated by the drive through facility is compatible with the commercial uses that Block 3 is designed to accommodate. The highest peak hour trip generation rate is for a coffee shop with drive-through; therefore, this rate was used even though the tenant is not known and may be a different category of drive-through restaurant. As such, the maximum potential impact has been accounted for in the design of the drive through facility.

- 3) The proposed use will not require extension or enlargement of the thoroughfare system at a higher net public cost than would result from a development permitted by right.

The proposed drive through use was analyzed for traffic impacts at the time of PMDD Master Plan Approval and Block 3 Site Plan Approval and will not require extension or enlargement of the thoroughfare system beyond that required to implement the MainStreet PMDD as a whole.

- 4) The proposed use will not require enlargement or alteration of utility facilities, drainage systems, and other utility systems other than what would result from a development permitted by right.

The proposed drive through facility was analyzed and accounted for in the master planning process for the MainStreet PMDD Master Plan and Block 3 Site Plan in order to ensure that sufficient utility facilities, drainage systems, and other utility systems are provided concurrent with the development. As such, the proposed drive through facility will not require enlargement or alteration of utility facilities,

drainage systems, and other utility systems other than what would result from a development permitted by right.

- 5) The proposed use will not demand greater municipal public safety services exceeding the demand resulting from a development permitted by right.

The proposed drive through use will not demand greater municipal public safety services exceeding the demand resulting from a development permitted by right. The MainStreet PMDD Master Plan and Block 3 Site Plan were designed with input from municipal public safety services to ensure that the ultimate development does not generate demand greater than a development permitted by right.

- 6) If a special land use is combined with other special land uses or permitted uses on a site, the overall intensity and scale of uses on the site is appropriate given the adequacy of proposed buffers and setbacks and the land uses of surrounding properties.

The proposed drive through facility is a component of the MainStreet PMDD commercial area within Block 3, which was previously reviewed and approved through the City's PMDD Master Plan and Site Plan approval processes. The overall intensity and scale of the uses including buffers and setbacks was reviewed in substantial detail and designed to ensure that the proposed drive through facility is appropriate.

CONCLUSION

In summary, the proposed drive through facility within Block 3 of the MainStreet PMDD complies with the standards within the City's Land Development Code for a Special Land Use. As such, Petitioner respectfully requests Special Land Use approval of the proposed +/- 2,800 square foot drive through facility in Retail D of Block 3 of the MainStreet PMDD.

The following trip generation calculation has been undertaken to evaluate the number of trips that will be generated by the development of Block 3 in comparison to the overall trip thresholds provided for in this project's master plan. The overall site is located within an area bordered on the east by Lyons Road, the south by Sample Road, the west by SR 7/US 441, and the north by Wiles Road. Figure 1 illustrates the location of the overall site and the location of Block 3 within the site.

The proposed plan of development for Block 3 includes a mix of general commercial and restaurant uses. Of the total 65,200 square feet that will be developed in this block, 40,200 square feet will be allocated for restaurant use, 2,800 square feet will be allocated for a restaurant with a drive through, and 22,200 square feet will be allocated for general commercial use. Table 1 below provides a summary of the total proposed entitlements for the site, the increments of development proposed for other blocks within the DRI, the increment of development proposed for Block 3, and the subsequent remaining entitlements available for other blocks within the master plan.

TRIP GENERATION DETERMINATION

A trip generation determination was prepared to determine the number of trips that would be generated by the Block 3 development. Table 2 provides a trip generation summary of the proposed Block 3 development. ITE Land Use 930 was utilized for determining the trip generation potential for the restaurant land use on site and ITE Land Use 934 was utilized for determining the trip generation potential for the restaurant space with drive through. Appropriate pass-by percentages from *ITE Trip Generation Manual, 11th Edition* were also applied for the applicable uses. As illustrated below, the proposed Block 3 development is expected to generate 258 AM peak hour trips (+144 in, + 114 out) and 480 PM peak hour trips (+251 in, +229 out).

It should be noted that the end user for the proposed restaurant with a drive-through has not been determined yet. Therefore, the trip generation rates for the types of restaurants with drive-through use that are included in the *ITE Trip Generation Manual, 11th Edition* were reviewed to determine the category that will generate the highest number of peak hour trips in order to provide the most conservative analysis. Based upon that review, the category “Coffee/Donut Shop with Drive-Through” was identified as the use that has the highest peak hour trip generation rate and was used for this analysis.

A summary has been prepared to compare the volume of trips for this block plus previously-submitted blocks to the total approved trip generation potential of the overall site master plan in order to calculate the number of trips remaining to be built. Table 3 provides this summary.

As shown, the remainder of the master plan will have entitlements remaining to generate a total of 229 additional AM peak hour trips and 509 additional PM peak hour trips remaining following development of the currently proposed Block 3 along with the other blocks previously submitted for individual site plan review.

TRAFFIC OPERATIONS

An overall traffic study was performed for the PMDD of both internal and external transportation facilities. That study provides a comprehensive review of off-site and on-site impacts, including elements such as traffic control and turn lanes. Development of Block 3 is contemplated in that analysis and therefore has been accounted for in that evaluation.

QUEUING ANALYSIS AT DRIVE-THROUGH

A drive-through queuing analysis was performed in accordance with the methodologies provided within *Transportation and Land Development, 1st Edition*. A Poisson Queuing analysis was performed for this site to determine the 95th percentile queue and to calculate whether the vehicle storage required is met by the vehicle storage provided within the drive-through lane. As indicated in the site plan, a total of approximately 300' of queue storage (12 vehicles) will be provided within the drive-through lane. Table 4 in the Appendix summarizes the queue calculations for the AM and PM peak hours of operations.

As summarized in Table 4, the 95th percentile queue was determined to be approximately 10 vehicles during the AM peak hour and 2 vehicles during the PM peak hour. Thus, the queuing area provided in the drive-through lane is expected to be sufficient to serve the queues and is not anticipated to create and impact on adjacent street traffic operation.

SUMMARY

As noted herein, the incremental development of 65,200 square feet (40,200 square feet of restaurant, 2,800 square feet of restaurant with drive-through, and 22,200 square feet of general commercial use) on Block 3 has been accounted for in the overall master plan for the Main Street project. This statement quantifies the Block 3 development in the context of the overall approved threshold of trips for the entire master plan.

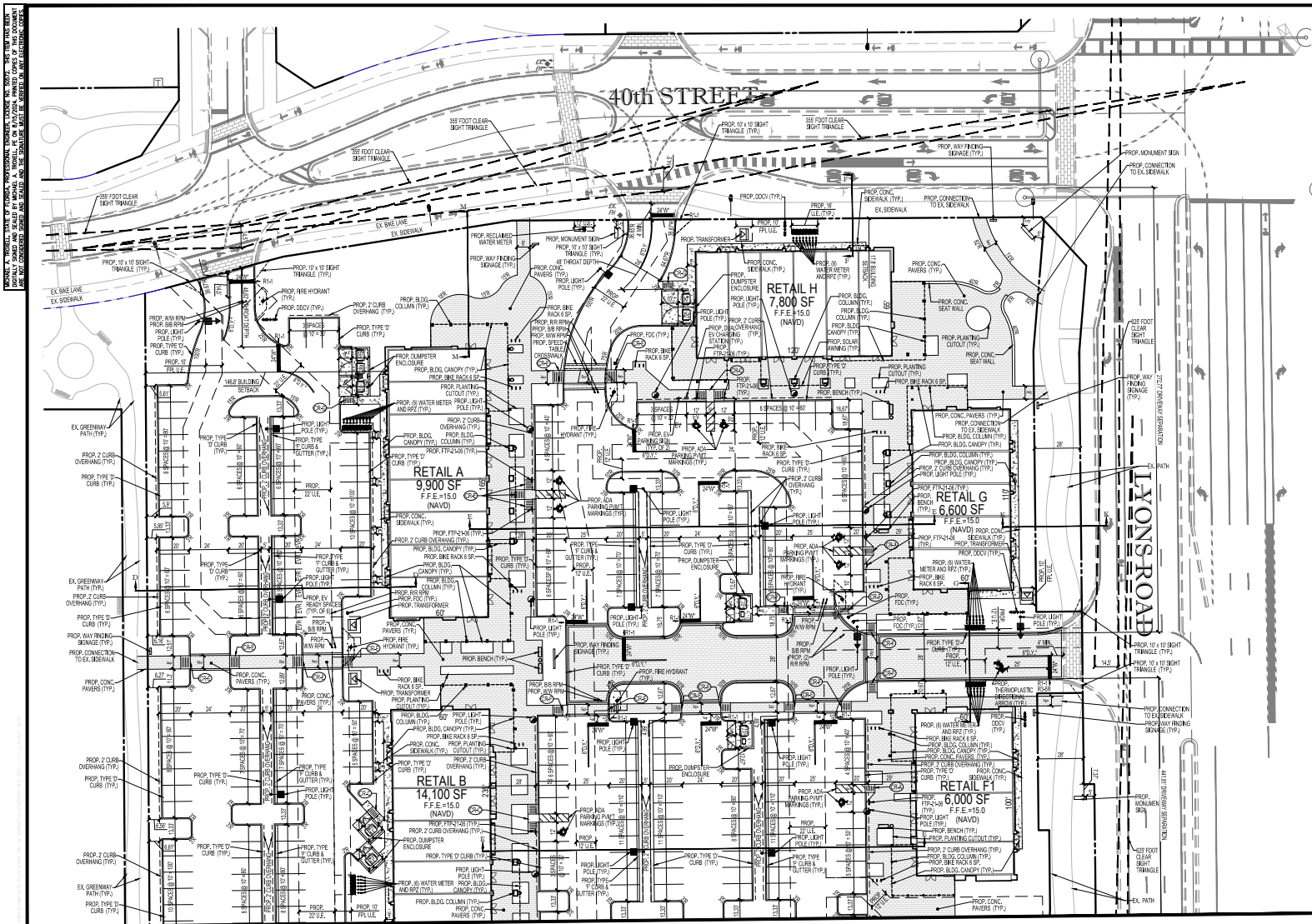

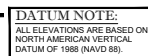

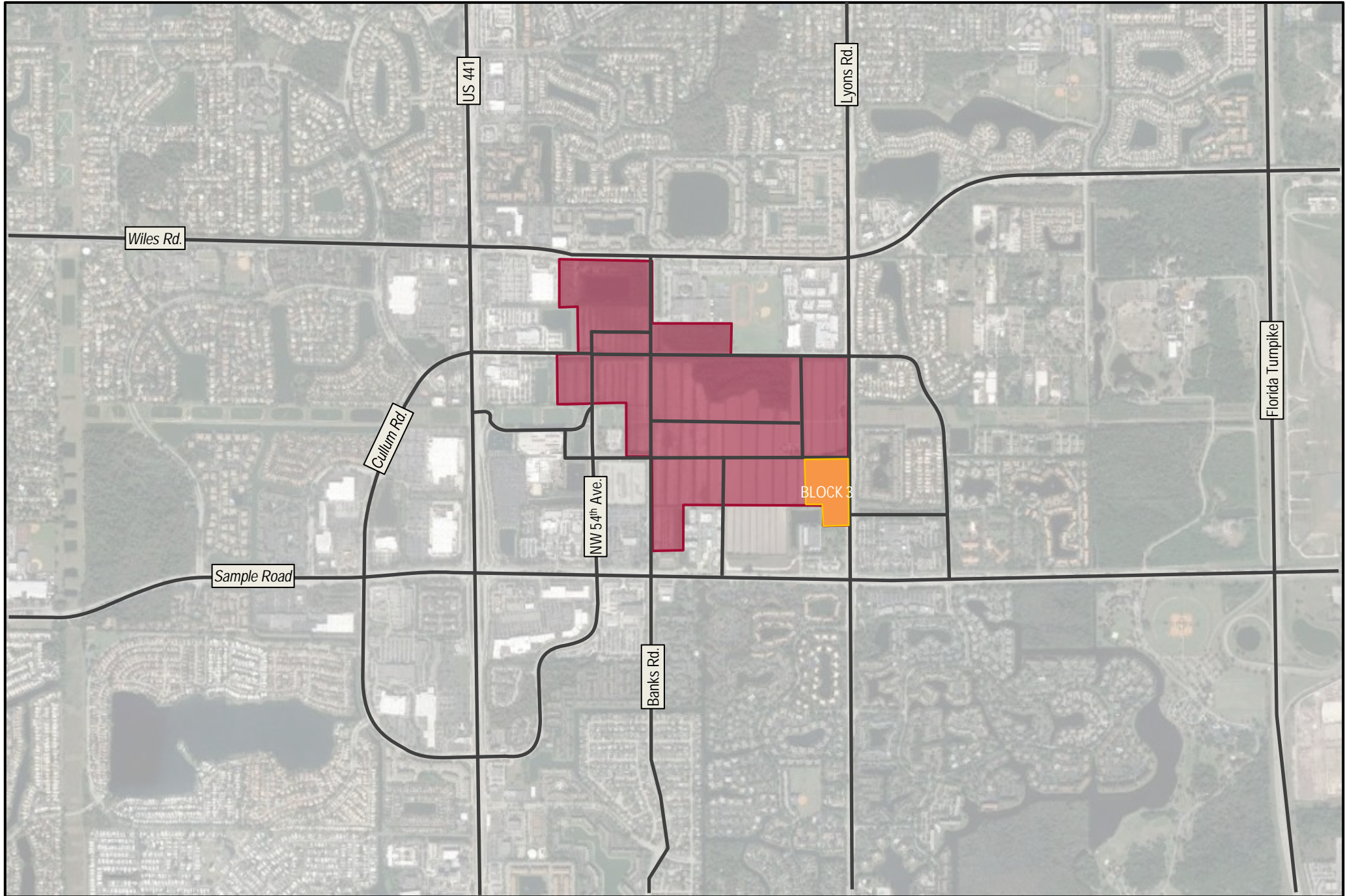

Coffee/Donut Shop with Drive-Through Window

Description

This land use includes any coffee and donut restaurant that has a drive-through window as well as a walk-in entrance area at which a patron can purchase and consume items. The restaurant sells freshly brewed coffee (along with coffee-related accessories) and a variety of food/drink products such as donuts, bagels, breads, muffins, cakes, sandwiches, wraps, salads, and other hot and cold beverages. The restaurant marketing and sales may emphasize coffee beverages over food (or vice versa).

A coffee/donut shop typically holds long store hours (more than 15 hours) with an early morning opening. Limited indoor seating is generally provided for patrons, but table service is not provided.

Coffee/donut shop without drive-through window (Land Use 936) and coffee/donut shop with drive-through window and no indoor seating (Land Use 938) are related uses.

Additional Data

The sites were surveyed in the 1990s, the 2000s, and the 2010s in California, Colorado, Connecticut, Illinois, Massachusetts, Minnesota, Nevada, New Hampshire, New Jersey, New York, Ontario (CAN), Pennsylvania, Quebec (CAN), Tennessee, Vermont, Washington, and Wisconsin.

Specialized Land Use Data

One study was conducted during the pandemic in 2020. Twelve sites were counted in Illinois and Missouri during the AM and PM adjacent street peak hours. The data have not been incorporated within the overall ITE trip generation database and are not reflected in the data plots for this land use. Consideration for their inclusion will be given for the 12th Edition of *Trip Generation Manual* after additional post-pandemic data are collected. Overall, the pandemic counts yielded an AM adjacent street peak weighted average rate of 84 vehicle trips per 1,000 square feet GFA, roughly equivalent to the pre-pandemic average. The PM adjacent street peak rate was 56 (roughly 40 percent higher than the pre-pandemic value). The higher PM peak rate for these coffee/donut shops conforms with anecdotal observations that with the temporary or permanent closures of many restaurants during the pandemic, the drive-through restaurants that were open did a brisk business even during their off-peak periods.

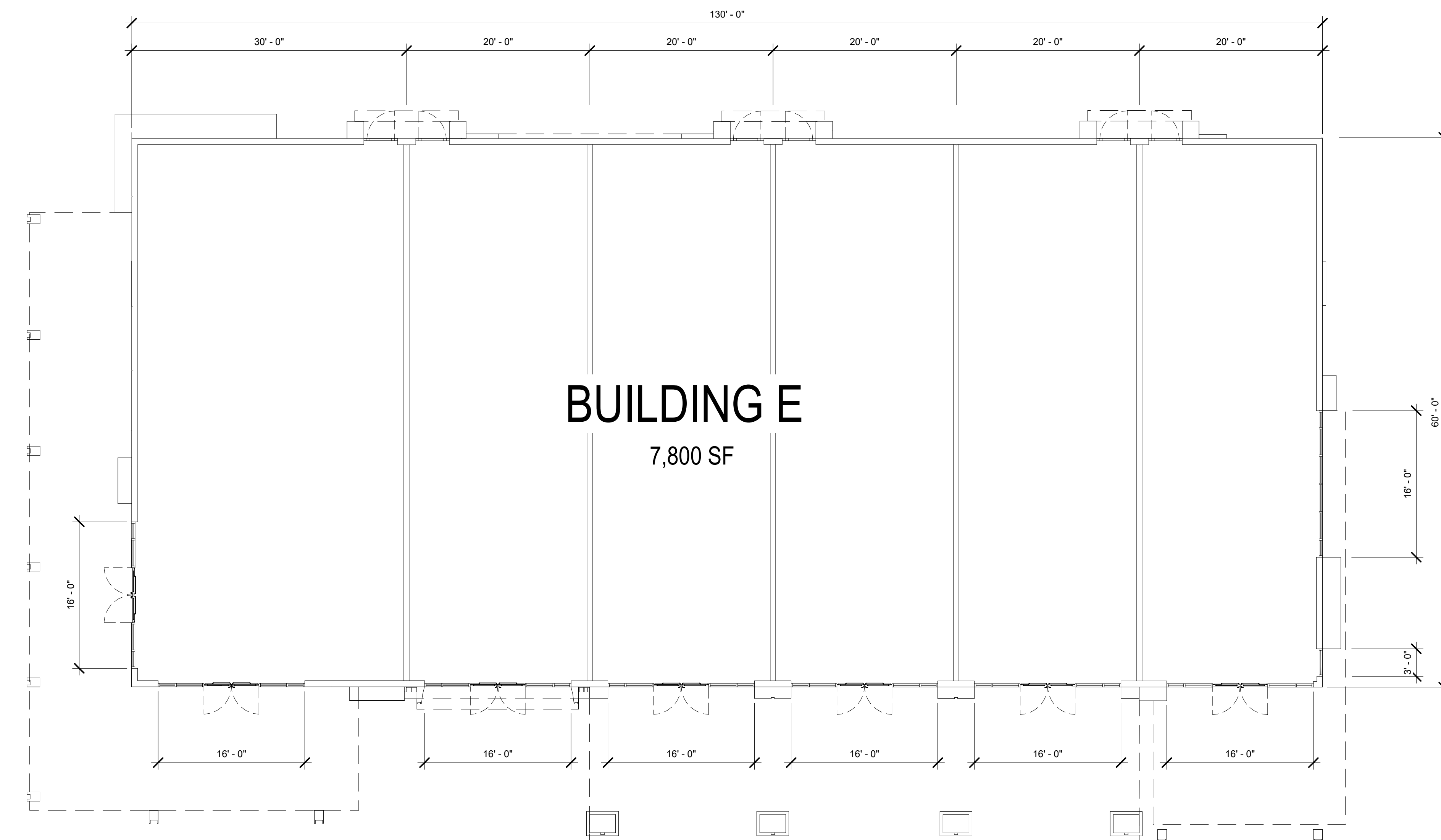
