RESOLUTION NO. 2021-226

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, ACCEPTING A GRANT IN THE AMOUNT OF EIGHT THOUSAND ONE HUNDRED FIFTY-FOUR DOLLARS (\$8,154); AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT (FDLE) AND THE CITY OF COCONUT CREEK FOR THE JUSTICE ASSISTANCE GRANT (JAG) FOR THE ENTANGLEMENT RESTRAINT PROGRAM (BOLAWRAP); PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek applied for and was awarded the Justice Assistance Grant by FDLE; and

WHEREAS, the grant provides Eight Thousand One Hundred Fifty-Four Dollars (\$8,154), which the Coconut Creek Police Department (CCPD) will use to purchase eight BolaWrap devices, eight BolaWrap holsters, and 42 boxes of BolaWrap deployment cartridges; and

WHEREAS, these BolaWrap devices will provide another less-lethal option for the CCPD; and

WHEREAS, the CCPD will use this hand-held, pre-escalation apprehension tool to restrain noncompliant subjects from a safe distance, reducing the use of force while increasing officer safety.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission hereby accepts the FDLE JAG in the amount of Eight Thousand One Hundred Fifty-Four Dollars (\$8,154).

<u>Section 3:</u> That the City Commission has reviewed and hereby approves the attached grant agreement between the FDLE and the City for the purpose of awarding Eight Thousand One Hundred Fifty-Four Dollars (\$8,154) to be used for purchasing eight BolaWrap devices, eight BolaWrap holsters, and 42 boxes of BolaWrap deployment cartridges.

Section 4: That the City Manager, or designee, is hereby authorized to execute said agreement between the FDLE and the City, attached hereto and made a part hereof.

<u>Section 5:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 6: That this resolution shall be in full force and effect immediately upon its adoption.
