

**RESOLUTION NO. 2023-201**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPROVING THE AMENDED NEIGHBORHOOD ENHANCEMENT GRANT PROGRAM GUIDELINES, ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT “A;” PROVIDING FOR A PUBLIC PURPOSE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek funds a Neighborhood Enhancement Grant (NEG) Program to provide matching funds for enhancements to the City's neighborhoods and communities; and

**WHEREAS**, the NEG Program was designed to stimulate and enhance neighborhood vitality by addressing the concerns and special needs of our neighborhoods; and

**WHEREAS**, the City is desirous of updating the NEG Program Guidelines by adding Universal Gate Access as an eligible project; and

**WHEREAS**, the City Commission finds that installing Universal Gate Access Systems throughout the community serves a public purpose and hereby determines that approving the amended Neighborhood Enhancement Grant Program Guidelines, as provided for in Exhibit “A,” is in the best interest of the safety and well-being of the residents of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission finds and determines that amending the Neighborhood Enhancement Grant Program is in the best interest of the residents in the City.

**Section 3:** That the City Commission has reviewed and hereby approves the amended Neighborhood Enhancement Grant Program Guidelines, attached hereto and made a part hereof as Exhibit "A."

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
