

**RESOLUTION NO. 2015-172**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING A TRANSFER OF FUNDS FROM GENERAL FUND CONTINGENCY TO THE NEIGHBORHOOD ENHANCEMENT GRANT PROGRAM; AND APPROVING THE WYNMOOR COMMUNITY COUNCIL APPLICATION FOR MATCHING FUNDS FROM THE NEIGHBORHOOD ENHANCEMENT GRANT PROGRAM FOR THE CONSTRUCTION OF A GUARD HOUSE AT THE LYONS ROAD COMMUNITY ENTRANCE; PROVIDING FOR CONDITIONS OF APPROVAL; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek has funded a Neighborhood Enhancement Grant Program to provide matching funds for enhancements to the City's neighborhoods and communities in the amount of \$27,162.50; and

**WHEREAS**, the Wynmoor Community Council has applied for \$20,000.00 in matching funds from the Neighborhood Enhancement Grant Program for the construction of a guard house at the community entrance on Lyons Road; and

**WHEREAS**, the Neighborhood Enhancement Grant Program requests for this Fiscal Year, including this project, total \$47,162.50; and

**WHEREAS**, the City Commission desires to increase the Program Budget from \$27,162.50 to \$47,162.50 by transferring \$20,000 from Contingency Account 0199-9901 to the Neighborhood Enhancement Grant Account 0198-8220; and

**WHEREAS**, the Wynmoor Community Council will provide the matching funds for labor and installation; and

**WHEREAS**, the Wynmoor Community Council has agreed to be responsible for maintenance.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the City Commission hereby authorizes a transfer of \$20,000.00 from Contingency Account 0199-9901 to Neighborhood Enhancement Grant Account 0198-8220 for this project.

**Section 2:** That the City Commission hereby approves the Wynmoor Community Council application for \$20,000.00 in matching funds for the construction of a guard house at the community entrance on Lyons Road.

**Section 3:** That the Wynmoor Community Council is responsible for providing matching funds for the labor, installation, and maintenance.

**Section 4:** That this Resolution shall be in full force and effect immediately upon its passage and adoption.
