RESOLUTION NO. 2017-002

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPROVING AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF COCONUT CREEK, THE CITY OF MARGATE, AND THE **BROWARD COUNTY SHERIFF'S OFFICE PROVIDING** COOPERATIVE **EMERGENCY** FOR **SERVICES** THROUGH AUTOMATIC AID FOR FIRE RESCUE FOR AN INITIAL TERM ENDING ON SERVICES SEPTEMBER 30, 2017, WITH FOUR (4) ONE-YEAR AUTOMATIC RENEWALS: AUTHORIZING THE CITY MANAGER TO EXECUTE THE ATTACHED AGREEMENT AND TO RENEW THE AGREEMENT UNDER THE SAME **TERMS** AND CONDITIONS WITHOUT **FURTHER** COMMISSION ACTION; **PROVIDING FOR** SERVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek, the City of Margate, and the Broward County Sheriff's Office (hereinafter "BSO") wish to enter into an Interlocal Agreement (hereinafter "ILA") for cooperative emergency services through automatic aid for fire rescue services, attached hereto and made a part hereof as Exhibit "A;" and

WHEREAS, the term of the ILA will commence upon approval by the Coconut Creek City Commission and end on September 30, 2017, with four (4) one-year automatic renewals or otherwise until terminated by the parties in writing; and

WHEREAS, the parties find that mutual cooperation in the delivery of fire rescue services can best be accomplished within a cooperative, interlocal configuration; and

WHEREAS, the City Manager, or designee, is authorized to execute the ILA and to renew the ILA under the same terms and conditions without further action by the City Commission; and

WHEREAS, the ILA is an equitable exchange of services that will not require monetary compensation from the parties.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. The ILA, attached as Exhibit "A," is incorporated herein and made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission of the City of Coconut Creek, Florida hereby approves the ILA between the City of Coconut Creek, the City of Margate, and the Broward County Sheriff's Office, providing for cooperative emergency services through automatic aid for an initial term beginning upon approval of this Agreement and ending on September 30, 2017, with four (4) one-year automatic renewals, and termination by either party with sixty (60) days written notice as set forth in the Agreement.

<u>Section 3:</u> That the City Manager, or designee, is authorized and directed to execute the ILA on behalf of the City of Coconut Creek and forward copies to the other parties to the Agreement.

Section 4: That the City Manager, or designee, is authorized to renew the ILA under the same terms and conditions without further Commission action.

<u>Section 5</u>: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

<u>Section 6:</u> That this Resolution shall be in full force and effect immediately upon its adoption.
