City Attorney Pyburn had no report.

#### **COMMISSION COMMUNICATIONS**

Commissioner Belvedere participated in a community meeting at Wynmoor and gave an update of City events and development. She noted that the residents were pleased with the growth of the City and the new *Dunkin Donuts* located on Coconut Creek Parkway.

Commissioner Welch spoke about the Jazz Under the Stars event held at City Hall and the Creek Idol singing competition. She attended a recent firefighter training event and visited the Reuter recycling facility in Pembroke Pines. She commented on the amount of household waste that had gone into the Monarch Hill landfill since Hurricane Irma and the importance of providing education regarding recycling in the schools.

Vice Mayor Rydell thanked Community Relations Director Yvonne Lopez for highlighting the local group *Coconut Creek Rocks* through the City's media outlets and commended her for responsiveness to residents through social media.

Mayor Tooley noted that she had received positive feedback from the residents on the Jazz Under the Stars event and commended City staff for their efforts on the event. She attended an event with Congressman Ted Deutch regarding the Sandy Hook Promise Program to help prevent gun violence in communities and noted that Congressman Deutch was applying for a grant to bring the program to Broward County schools. She spoke about a local high school student who recently lost her life in a traffic accident and thanked the Police Department for the wonderful job they did assisting attendees at the memorial service. She went on a tour of Windmill Park, which was under construction for renovations, and commented on the new walking trails and exercise equipment.

5. RES A RESOLUTION APPROVING THE CITY OF COCONUT CREEK'S 2018-028 2018 FEDERAL LEGISLATIVE AGENDA.

Mayor Tooley read the Resolution title into the record.

**MOTION:** Rydell/Welch – To approve Resolution No. 2018-028.

Mayor Tooley introduced the City's federal lobbyist, Greg Burns of Van Scoyoc and Associates, who spoke briefly regarding the City's legislative priorities for 2018 and confirmed that he would be adding three items based on feedback from the Commission Workshop – monitoring legislation regarding geoengineering, sanctuary cities, and federal marijuana policy.

Upon roll call, the Resolution passed by a 4-0 vote.

A RESOLUTION AUTHORIZING THE USE OF FEDERAL LAW ENFORCEMENT TRUST FUNDS IN THE AMOUNT OF \$635,540 FOR THE PURCHASE OF POLICE RATED VEHICLES WITH NECESSARY EQUIPMENT, LAPTOPS WITH POLICE SOFTWARE AND ACCESSORIES, MOTOROLA PORTABLE RADIOS WITH ACCESSORIES, SALARY CONTRIBUTION FOR SCHOOL RESOURCE OFFICERS IN FISCAL YEAR 2018, BI-DIRECTIONAL AMPLIFIER CONDUIT INSTALLATION FOR COCONUT CREEK HIGH SCHOOL, AND CRIME PREVENTION TECHNOLOGY ENCHANCEMENTS (AUTOMATED LICENSE PLATE RECOGNITION).

Police Chief Albert "Butch" Arenal presented the item. He spoke briefly about staffing for the School Resource Officer positions and costs associated with the installation of the bi-directional amplifier at Coconut Creek High School. Discussion ensued regarding cost itemization and additional support material for each of the expenditures requested.

AMENDMENT: Welch/Belvedere - To amend Resolution No. 2018-002 to remove item 5 of the

staff Interoffice Memorandum, Crime Prevention Technology Enhancements, from the request for Law Enforcement Trust Funds and adjust the funding amount to

\$385,540.

Upon roll call, the Resolution, as amended, passed by a 4-0 vote.

7. ORD 2017-053

AN ORDINANCE AMENDING CHAPTER 16, "OUTDOOR SALES AND ACTIVITIES," ARTICLE I, "IN GENERAL," SECTION 16-1, "PURPOSE AND INTENT," TO PROVIDE FOR AN UPDATED PURPOSE AND INTENT; AMENDING SECTION 16-2, DEFINITIONS," TO PROVIDE FOR UPDATED TERMINOLOGY; AMENDING ARTICLE IV, "SOLICITOR REGULATIONS," SECTION 16-5, "SOLICITOR REGULATIONS," TO PROVIDE FOR UPDATED REGULATIONS: ENACTING A NEW SECTION 16-6, "PROHIBITED ACTS" IN ORDER TO PROVIDE FOR SAME; ENACTING A NEW SECTION 16-7, "RIGHT-OF-WAY CANVASSERS AND SOLICITORS" IN ORDER TO PROVIDE FOR REGULATIONS REGARDING CANVASSING AND SOLICITING IN THE TEN MOST DANGEROUS INTERSECTIONS IN THE CITY; AND ENACTING A NEW SECTION 16-8, ENFORCEMENT AND PENALTIES. (SECOND READING)(PUBLIC HEARING)

City Attorney Pyburn read the Ordinance title into the record.

MOTION: Welch/Rydell – To adopt Ordinance No. 2017-053.

Police Legal Advisor Jeannette Camacho explained the requirements for solicitors to obtain permits and photo identification badges. City Attorney Pyburn discussed several methods of notifying the public of the new ordinance. Assistant City Manager/Sustainable Development Director Sheila Rose discussed the proposed changes related to distance regulations, noting that the amended ordinance prohibits soliciting within the ten most dangerous intersections and within 250 feet of the right-of-way. Discussion ensued.

Mayor Tooley opened the public hearing.

Patricia Duaybes, 4106 Oxbow Drive, Coconut Creek, asked about protesting within 250 feet of the right-of-way, and City Attorney Pyburn explained the enforcement process and noted there were alternate locations where protesting could take place other than the ten most dangerous intersections. There were no further questions or comments from the public, and the public hearing was closed.

Upon roll call, the Ordinance passed by a 3-1 vote, with Vice Mayor Rydell voting nay.

Mayor Tooley read the Resolution title into the record.

**MOTION:** Belvedere/Rydell – To approve Resolution No. 2018-032.

Assistant City Manager/Sustainable Development Director Sheila Rose presented the item. Discussion ensued regarding the design of the art pieces and proposed locations.

Upon roll call, the Resolution passed by a 4-0 vote.

9. RES 2017-234

A RESOLUTION AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT WITH KLEMOW AT 5100 HILLSBORO, LLC AND FIRST BAPTIST CHURCH AT COCONUT CREEK, INC. (DEVELOPERS) FOR THE DESIGN AND CONSTRUCTION OF IMPROVEMENTS TO THE COCONUT CREEK 69TH STREET GREENWAY AND THE ASSOCIATED CONSTRUCTION AGREEMENT.

Mayor Tooley read the Resolution title into the record.

**MOTION:** Welch/Rydell – To approve Resolution No. 2017-234.

Sustainable Development Deputy Director Scott Stoudenmire presented the item and noted that Attorney Richard Coker was present to answer questions on behalf of the developers. Mr. Stoudenmire noted that the City would maintain the improvements after they were constructed.

Upon roll call, the Resolution passed by a 4-0 vote.

10. ORD 2018-002

AN ORDINANCE AMENDING THE CODE OF ORDINANCES, CHAPTER 13, "LAND DEVELOPMENT CODE," BY AMENDING ARTICLE III, "ZONING REGULATIONS," DIVISION 4, "ACCESSORY USES AND STRUCTURES," SUBDIVISION IX, "WIRELESS COMMUNICATIONS FACILITIES," SECTIONS 13-538, "ANTENNAS NOT LOCATED ON TOWERS," 13-541.3, "PLACEMENT OR MAINTENANCE OF A WIRELESS COMMUNICATIONS FACILITY IN PUBLIC RIGHTS-OF-WAY," AND 13-541.13, "ENFORCEMENT REMEDIES," IN ORDER TO UPDATE THE CITY'S TELCOMMUNICATIONS ORDINANCES TO COMPORT WITH RECENT CHANGES TO STATE AND FEDERAL LAW AND TO ENSURE CONSISTENCY WITH INDUSTRY STANDARDS. (FIRST READING)

City Attorney Pyburn read the Ordinance title into the record.

**MOTION:** Welch/Rydell – To adopt Ordinance No. 2018-002.

Assistant City Manager/Sustainable Development Director Sheila Rose presented the item and noted that Rick Edwards and Elizabeth Herington-Smith from CityScape Consultants were present to answer technical questions. Mr. Edwards gave a brief overview of the amendments. Discussion ensued regarding the administration and enforcement of the Ordinance.

**AMENDMENT:** Rydell/Welch – To amend Ordinance No. 2018-002 by changing the language from Director of Sustainable Development to City Manager, or designee.

Upon roll call, the Ordinance, as amended, passed by a 4-0 vote.

11. ORD 2018-001

AN ORDINANCE VACATING, RELEASING, AND ABANDONING A PORTION OF A 15-FOOT WATER UTILITY EASEMENT FOR THE PROJECT KNOWN AS GUNTHER MOTORS LOCATED AT 4350 NORTH STATE ROAD 7. (SECOND READING)(PUBLIC HEARING)

City Attorney Pyburn read the Ordinance title into the record.

**MOTION:** Welch/Rydell – To adopt Ordinance No. 2018-001.

Assistant City Manager/Sustainable Development Director Sheila Rose presented the item and noted that the applicant, Joseph Roles, was present to answer questions.

Mayor Tooley opened the public hearing. There were no questions or comments from the public, and the public hearing was closed.

Upon roll call, the Ordinance passed by a 4-0 vote.

12. ORD 2018-003

AN ORDINANCE AMENDING CHAPTER 13, "LAND DEVELOPMENT CODE," ARTICLE III, "ZONING REGULATIONS," DIVISION 2, "ZONING CLASSIFICATIONS AND GENERAL REQUIREMENTS," BY AMENDING SECTION 13-321, "MEDICAL MARIJUANA TREATMENT CENTERS," BY RENAMING IT "MEDICAL MARIJUANA TREATMENT CENTERS AND MEDICAL MARIJUANA DISPENSARIES" IN ORDER TO UPDATE THIS SECTION TO COMPORT WITH RECENT CHANGES TO STATE LAW; PROVIDING FOR APPLICATION REQUIREMENTS, DEVELOPMENT CONDITIONS, AND PROCEDURES FOR DENIAL AND REVOCATION. (SECOND READING)(PUBLIC HEARING)

City Attorney Pyburn read the Ordinance title into the record.

**MOTION:** Welch/Belvedere – To adopt Ordinance No. 2018-003.

City Attorney Pyburn noted that Broward County recently voted to regulate medical marijuana dispensaries. She added that there were eight other municipalities within Broward County that voted to regulate medical marijuana dispensaries, several cities had moratoriums in place, and approximately fifteen municipalities voted to ban the facilities. Vice Mayor Rydell asked for staff to monitor applications submitted to Broward County subject to their Ordinance.

Mayor Tooley opened the public hearing. There were no questions or comments from the public, and the public hearing was closed.

Upon roll call, the Ordinance passed by a 4-0 vote.

13. ORD 2018-004

AN ORDINANCE AMENDING CHAPTER 13, "LAND DEVELOPMENT CODE," ARTICLE III, "ZONING REGULATIONS," DIVISION 8, "MASTER BUSINESS LIST," SECTIONS 13-621, "MASTER BUSINESS LIST - B-2, B-3, AND B-4," 13-623, "MASTER BUSINESS LIST - O-2, O-3," AND 13-625, "MASTER BUSINESS LIST - MSOA," TO PROVIDE FOR "MEDICAL MARIJUANA DISPENSARY" USES AS A SPECIAL LAND USE AMONG THE USES LISTED. (SECOND PUBLIC HEARING)

City Attorney Pyburn read the Ordinance title into the record.

**MOTION:** Welch/Rydell – To adopt Ordinance No. 2018-004.

Assistant City Manager/Sustainable Development Director Sheila Rose presented the item.

Mayor Tooley opened the public hearing. There were no questions or comments from the public, and the public hearing was closed.

**Upon roll call, the Ordinance passed by a 4-0 vote.**
