

RESOLUTION NO. 2018-005

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ROHL GLOBAL NETWORKS LP FOR THE CONSTRUCTION OF THE RECLAIMED WATER MAIN EXPANSION PROJECT ON WILES ROAD AND LYONS ROAD PURSUANT TO BID NO. 10-25-17-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek (City) has identified reclaimed water as an alternative water supply source for its service area and as a major component of the City's Green Plan including the Reclaimed Water Master Plan; and

WHEREAS, the City has an existing reclaimed water main connection with Broward County's reclaimed water interconnect on Wiles Road and NW 39th Avenue; and

WHEREAS, the City completed the design to extend reclaimed water services west along Wiles Road from NW 39th Avenue to Lyons Road, and then south to Cullum Road for future expansion in the MainStreet Project Area, and north for irrigation of medians; and

WHEREAS, the City obtained a grant from the South Florida Water Management District for \$300,000 towards this project; and

WHEREAS, the City entered into an interlocal agreement with Broward County in 2017 for cost sharing of this project in the amount of \$200,000; and

WHEREAS, in 2017, the City received bids from nine contractors, pursuant to Bid No. 10-25-17-11: Rohl Global Networks LP, Southern Underground Industries, Inc., R.P. Utility & Excavation Corp., Roadway Construction LLC, DBE Management, Inc., Pabon Engineering, C&W Pipeline, Inc., David Mancini & Sons, Inc., and Lanzo Construction Co., Florida; and

WHEREAS, the Purchasing Division reviewed the bid responses for compliance and no issues were found; and

WHEREAS, the lowest responsive bidder was found to be Rohl Global Networks LP; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with Rohl Global Networks LP for the construction of the reclaimed water main expansion project on Wiles Road and Lyons Road in the amount of \$1,385,000.00 pursuant to Bid No. 10-25-17-11.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

Section 2: That the City Commission has reviewed and hereby approves the Agreement between the City of Coconut Creek and Rohl Global Networks LP for the reclaimed water main expansion project on Wiles Road and Lyons Road in the amount of \$1,385,000.00 pursuant to Bid No. 10-25-17-11.

Section 3: That the City Manager, or designee, is hereby authorized to execute the Agreement between the City of Coconut Creek and Rohl Global Networks LP.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
